Bangladesh ram chhung buai chungchangah Council for World Mission-in Presbyterian Church of India General Assembly hnena ṭawngṭai rual tura a ngenna chu PCI chuan ṭha tiin, Synod hrang hrang te chu August 31, 2024 (Inrinni) zan inkhawmah Bangladesh puala ṭawngṭai rual turin min rawn ngen a. Synod OM 20:18 of 20.8.2024 chuan PCI-in min rawn ngen ang hian **August 31, 2024 (Inrinni) zan inkhawmah** Bangladesh ram tan hian Kohhran tinah ṭawngṭairual neih ni se tiin a rel a, ka han hriattir a che.

Ṭawngṭai rual thupui tur hetiang hi a ni:

1. **Remna leh ralmuanna:** Bangladesh-a remna leh ralmuanna a awm theih nan. Buaina thleng mēk avang hian mipuite zingah hlauhna leh rilru buaina a thleng nasa hle a. Tharum thawha inbeihna a tāwp theih nan leh harsatnate hi muanawm taka chin fel a nih theih nân ṭawngṭai ni se.
2. **Sawrkar hruaitute tan:** Bangladesh ram hruaituten finna, huaisenna leh mipuite lainatna nei chunga hēng hun harsa kara ro an rel thiam theih nan. Pathian a inrawlh a, ram hruaituten inremna leh a tuam dam zawnga thutlūkna dik an siam theih nana Pathian puikhna dilpui ni se.
3. **Him taka mipuite an awm theih nan:** Bangladesh ram khua leh tui zawng zawnge, a bik takin mirethei leh chhumchhiate him taka an awm theih nan. Curfew avang leh mamawh châkkhai lam khâwm a harsat avangin mi tam tak tan nitin nunah harsatna namên lo a thleng mēk a ni.
4. **Inbiak pawhna leh inzarzawmna atan:** Inbiak pawhna ṭha leh internet te a pangngaia a kal leh theih nan. Chanchin ṭha hrilna lama kan rawngbawlpuite leh khawvel hmun danga kan mihringpuite nena inpawhna ṭha neih hi inpuih nan leh harsatna min tuarpui zel theih nan thil pawimawh tak a ni.
5. **Damma leh thlamuanna atan:** Chhungkaw tam tak leh khawtlangin lungngaihna nasa tak an tuar a. Buaina avanga an hmangaihte chān taten an tuar mek lai pawha thlamuanna leh chakna an neih theih nan.

6. **Rinna leh Inpumkhatna atan:** Bangladesh rama kohhrante leh saklaw dang vuantute inpumkhat leh thukhat vuua chak taka an din ho zel theih nan. Hetiang hun thim tak karah kohhran hi beiseina leh hmangaihna meichher êng chhitu a nih zel theih nan leh mamawhtu apiangte mamawh chhâna a nih zel theih nan.
