

'Hun leh tuilianin min nghak lo,' an lo tih thin angin, 'Ber' thla rapin kum tawp lam kan lo hnaih leh ta. Kohhranho te Beihral thla hmang turin kan inbuatsaih sung sung a, hmasawnpui ngei tum theuh ila a duhawm hle.

*Kan hriat theuh angin Beirual thla kan hman kar hnuhnung ber hi **Kristian Chhungkaw** puala hman a ni a, hemi kar tluan hian Kristian chhungkaw chungchang then hrang hrang zir a ni thin a, tun tumah pawh hian thupui then hrang hrang tha tak tak - Chhungkaw Pawimawhna, Mizo Kristian Inneihna, Kawppui zawn leh Inneih, Kristian chhungkua leh politics tih te, Kristian Chhungkua leh hnathawh te, Chhungkaw Inlaichinna tha te, Kristian Chhungkua leh Khawtlang nun tih te, etc. kan zir leh dawn a, kar khat chhung kan zir ho thin kha tum kua lai kan zir dawn a, a lawmawm hle a ni.*

*September 26, 2010 - Pathianni chu Kristian Chhungkaw Ni atana hman tura Synod-in a rel angin hman a ni thin a; kan chanchinbu-ah pawh Kristian Chhungkaw Ni pualin Sermon te kan han tichhuak nghe nghe a ni. I Sam. 1:20-23; 2:29-33; Joba 4:7,8.

Vawiina kan rama sualna leh harsatna hrang hrang thlengah hian, ‘*nu leh paten mawh kan phur a ni*,’ ti ngam theuhin, mawhphurhna kan hlenchhuah loh leh kan nun tha lo lai siam tha ngam theuh ila chuan kan tu leh faten entawn tur an nei ang a, kan ram hi a ziaawmin a dam leh ngeiin ka ring thin. Mihring nuna hlawhtlinna emaw, hlawhchhamna emaw lo thleng thin hi tihpalh thila thleng ta ringawt a ni lo va, naupan lai atanga kan inenkawl danin a ken tel leh a zik chhuahpui pawimawh tak a ni zawk. Chutichuan, kan ram sualna leh rumna hi kan tu leh fate kan enkawl leh kaihhruai dan dik tawk loh vang ni mai lovin, a kaihhruai dan kan hriat loh leh thiam tawk loh vangte pawh a ni tel a, a ril em em a ni. Chuti chungin, nu leh pa thenkhat chuan a zir pawh kan peih lo va, a tum pawh kan tum peih hek lo hi, a pawi tak zet a ni.

Naupang enkawl hi thil har tawp, thapui thawh ngai a ni a, thapui kan thawh pawhin eng nge kan an ang, tih nak alaiin, thapui kan la thawh duh lo lehngthal hi chu setana tan chuan a hahdamthlak ngawt ta ve ang. Tum khat chu Nepoleona leh Mrs. Balcombe-i te an lendunnaah, naupang bal leh tawp tak mai an hmu a. Mrs. Balcombe-i chuan ‘*He naupang hi zirtir a va han tul tehlul em*,’ a ti a,

Nepoleon-a chuan, ‘*He naupang hi zirtir a ngai lo, a enkawltu a nu leh pa hi zirtir an tul zawk a nih hi*’ a ti hmiah mai. Napoleon-a vek chuan, ‘*Sipai tha lo an awm lo va, hruaitu tha lo erawh an awm thei*’ a ti bawk. Nu leh pate hi kan inzir a tul tak meuh a, a chhan lian takah chuan, mihring hi enkawl ngai saa piang kan nih miau vang a ni, rante ang lo takin kaihhruai kan ngai a, pianpui tawng kan

nei lo va, zirtir ngai kan ni, pianpui mizia pawh min zirtirtu leh kaihruaitu azirin kan thlak mai thei bawk. Chu mawhphurhna chu nu leh pa te ko-a innghat a ni.

Naupang enkawl kawngah hian Mizote hi kan tlai em? Kan Bible-in, '*Engkim tan hian hun ruat a awm a*', a tih angin, mihring siam that hun pawh hi a awm a ni. Mi thiamte chuan, mihring tung chho pangngai-ah chuan kum 2-3 vel atang hian ngaihtuahna leh thlir dan kan nei ve ḫan a, chuta kan ngaih dan hmasaah chuan kawng li a awm thei a ni an ti, chungte chu - (1) mahni aia midang ḫa leh tling zawka ngaihna emaw (2) mi dang aia mahni ḫa leh tling zawka inngaihna emaw (3) mahni leh mi dang tling lo leh ḫa lo ve ve a ngaihna emaw leh (4) mahni leh midang tling leh ḫa ve vea ngaihna te an ni.

Hetah hian a hmasa pathumte hi ngaih dan ḫa lo te an ni a, a pathumna phei hi chu a ḫa lo lehzualin mi hnawksakte ngaih dan leh thlir dan a ni. Chuvangin, a palina '*Nang i ḫha a, kei pawh ka*

tha, ' tih ngaih dan neia thanlenpuitute hi mi hlawhtling an ni ḫin a, an bula awm a hahdamthlak a, amah pawhin mi dang bula awm nuam a ti bawk a ni, an tih avangin chu ngaih dan chu kan tu kan fate thinlungah kan tuh a pawimawh em em a ni.

Heng ngaih dan pali zinga a eng bera emaw hi kum sarih kan nih chuan kan dam chhung atana kan miziaa bet tlat tawh turin zaa sawmsarih leh panga (75 %) zet chu a lo insiam fel hman vek tawh a; chuvangin, kum sarih hnuai lam hi a pawimawh tak zet a ni. Chulai hunah chuan nu leh pa ḫenkhhat chuan naupang kan chhawnchhaihin kan be chhawhchhi a, an zawhna ka chhang ḫa duh lo va, chhungkaw ḫenkhhat phei chuan naupang kan kawl chuan kan ḫawng fiah lo fai ve vek ringawt bawk a, dawt te kan hrilh a, kan tih thaih thul, mi kan rel khum thul, ḫenkhhat lahin awmpuite kutah kan dah tawp mai bawk nen, an tan hian a manganthlak tak zet thin. Kum sarih hnuai lama kan inenkawl dan a dik loh

chuan, tleirawl/rawlthar an nih vel aṭangin a rah ze ṭha lo a rawn lang chhuak ang, chutah meuh chuan nu leh pa kan buai a, '*kan enkawl thei tawh thlawt lo*', tih a lo ni ta a, a kaikuang ber hre chuang si lovin puh tur kan zawng kual a, a damdawi tur ṭha kan zawng kual bawk a, Home/Centre hrang hrang, camping a ṭul, kohhran, sawrkar, khawtlang hruaitute kan ti kual ta ṭhin a ni.

Naupang kum sarih hnuai lamte hian an hriat rengna (*memory*) hmangin thil an ngaithlain an zir a. Ziak leh chhiar an la thiam ve tak tak loh avangin, an thu ngaihthlak leh an thil hmuhte chu an thinlungah an khawl khawmin an ṭhanlenpui mai ṭhin. Chuvangin, hetih hun laia thil ṭha lo hrilh leh an rilru hliam te, ennawm (*film*) ṭha lo ente hi a pawi khawp asin. **S-i** chu kum 4 mi lek a nih laiin, a pain a nu chu raicheh (*S-i a hrin laiin*)-a thi a nih thu a hrilh a, a lo ṭhanlen hnu chuan nun hlim a nei ngai lo va, a ngui reng ṭhin, engati nge? Tualthattu, a nu thattu nia

inngaihna thinlung a pu tlat alawm, a pawi hle a ni. Hei hi Counsellor nen an inkawmna aṭangin an hre chhuak ta a ni. A pa hian a tum reng ni loin a fanu rilru natna a thlen tlat mai, naupang bula thusawite hi fimkhur a ṭul hle a ni. Naupan laia enkawl that loh leh kawng dika hruai lohten ram an kaihruai a, sawrkarah nihna pawimawh leh dinhmun sang an chelh a nih chuan ram a rum a, sualna a ngampa a, hmasawnna a awm har ṭhin a ni tih i hre thiam teh ang u.

Chu chu a ni kan Bible chang tarlan I Samuela 1:20-23-ah khan kan hmu a, Elkana leh a chhungte chu an kum tin dan ṭhulh an hreh em em inthawina hlan turin an kal chho ṭhin a, chhungkua an kim ngei ngei ṭhin; mahse, Hani chuan, '*naute hnute hnek ban hunah*,' a tih tlat mai, thil dang a ni lo, Samuela'n a lo puitlin hunah Lalpa rawng bawla ram roreltu ṭha a nih theih nan a nu-in kalsan a rem lo va, a enkawl leh kawng a sah hmasak a ṭul tlat. Pharaoa fanuin chhiahhlawh leh nau

awmtu ngah hle mah se, Mosia chu '*Hruaitu Ropui*' a lo nih theih nan, Pathianin a naupan laia awm turin a nu a thlang tlat a ni, mi dang kuta dah chi an ni lo. Thu tha, Pathian thu hrilh tam in, kawng dik i kawhhmuh ang u; tah chuan, an lo thanlen hunah kan ram hi a dam leh ang a, Lalpa a ropui ang. Thuf. 2:6-ah chuan '*Naupang chu a kalna awm kawngah chuan zirtir ula, A upat hun pawhin pawhin a thlah lo vang*' tih kan hmu a.

Mihring siam thatna atan hun duhawm ber chu naupan lai a ni. Naupang zirtir that hi nun pum pui (full-person) zirtir tha kan ni e. '*Kan faten kum sarih an pel tawh si a, kan tlai der tawh a nih chu*', tiin kan beidawng a ni mai thei. Beidawn a thiang lo va, a la tlai lo ve, zaa sawmhnih leh panga (25%) kan la nei alawm. Thahnmengai taka, tawngtaina nen kan zirtir a nih chuan, kan enkawl tur kan tu kan fate hian an thil tawn leh an chhehvel thil atangtein an damin an la danglam thei tih hriain i tang sauh sauh zel ang u. Kan

ramin nu leh pa tha, Pathian tihna nena fanau enkawltu a mamawh a nih hi.

Aw le , naupang enkawl dan kawng thum chauh han thlir ta ila -

1. Khauh taka thununna leh hremna nena enkawl.
2. Dimdawih tak leh tihnat hlau reng renga enkawl.
3. A hmasa pahnih tang-kawp leh an mize mila zalen taka enkawl te hi.

Nu leh pa tam tak chuan kan thahnemngaihna leh rual awhna te avang pawh a ni ang, a pakhatna ang hian kan tu kan fate kan enkawl duh khawp mai. Nu leh pa thiam loh vek bik pawh ni lo mah se chu chuan a chher puitling vek si lo. Khawng takin sipai inthununna ang takin kan enkawl a, mut hun thawh hun, dah fel tur, '*suh*' leh '*rawh*', kan sawi zung zung a, kan thu an zawm loh chuan kan hrawk zui hrep loh pawhin kan hrem thin. Hetiang hnuia naupang a seilen chuan hlauhna leh venthawnna nen, tihsual hlau reng rengin Thlamuang lovin a hun a hmang thin. Chumi

avang chuan in chhung nuam lo tihna leh chep nia in hriat hun apiang thei a. Eng tik niah emaw pawn lamah thlamuanna leh zalenna zawnga a vah chhuah hun kan nawr thlen chuan nu leh pa manganga kan တာ နှင့် a thleng ve thung thei asin. Vawiina kan rama sualna kan buaipui tam tak hi naupang thlamuang lote nun rah chhuah a nih hi.

Nu leh pa တော်ကွန်တဲ့ chuan a pawina hre hauh lovin kan တာနိမ်မြတ်နား lamah, an theih ang tawk an tih ve te pawh fak tak aruangin, kan sawisel hram a, anmahni thunun nana hmang zuuin, mi dang nen kan khaikhin a, an tluk lohte kan sawi chamchi တဲ့ thin. Patla (bûkna) kan khai reng a ni ber mai, hei hian naupang a tihbeidawn theih avangin thil pawi tak a ni. ***Naupang Z-i*** chu lehkha thiam thei pangngai tak a ni, a tih တဲ့ သေမား pawh a pa chuan a tluk lohte sawi chhuakin a kam khat hram တဲ့ thin. '***Theihtawp chhuah mah il a ka pa a lawm chuang lo***', tih chuan a rirruah beidawnna a tuh avangin Class - XII a

fail ta hial a, tah chuan a chhe zo ta, a pa hmuh chu a thil huphurh ber a ni, a nu nena တာ တူန် a pa hnena ngaihdam a dil a, a pain lo ngaidam mah se a tlai tawh tlat, Class - XII a pass-tir thei tawh chuang lo, a nun a chhe chho ta, a pawi a ni. Tu thiam loh nge? Heng avanga mahni intihlum hial pawh awm theih a nih avangin fimkhur a တဲ့ hle a ni. Naupang kan hrawka kan hrem a, hrehawm takin kan siam a ni ang e, chutiango ti mah ila '***Naupang chuan an theihngihlh leh mai a, an lungawi leh mai thin***', te kan ti thla rawk thin. Theihngihlh hi '***a dam ta***' tihna a ni lo va, theihngihlh hi hriat chhuah leh chang a awm thin asin. Huatna kan tuh tel phei chuan, a tirah lang nghal lo mah se huatna hian phuba a ken tel တဲ့ thin avangin a pawi hun a thleng thei tih i hre tel zel ang u. Nu leh paten kan duhthawh leh rualawhna avanga naupang phak lo chung nawr luih vak kan chingte pawh hian beidawnna a thlen thei tih hriain i fimkhur ang u.

Tumkhat chu kan ḥtian pakhatin fiamthua chhungkaw awhawm chanchin a sawi chu, "An nupa inhauhna ber pawh 'My dear, nang a thial hi ei ta che' an ti nia," a ti a. Ar thial ei tura induhsakna pawh an inhauhna na ber a nih chuan chu chhungkua chu an inhau dawn lo a, induhsakna leh ihmangaihna chu an chhungkaw nunphung tur a ni dawn a, a va nuam dawn em tih min ngaihtuahtir hle a. Hetiang chhungkua hi Kristian chhungkaw zia chu a ni a, kan ramah hian kan awm ang em aw tih min ngaihtuahtir hle mai.

Cachar Tlangrama Winchester School-a ka thawh laiin kan Hostel naupangte chu kan theih ang tawka tha leh duatin enkawl vein kan inhria a. Mahse, School chawlh veleh hian hmanhmawh tak maiin an haw ḥthin a. An in leh lo chu a ḥtha lo ve hle a, hostel-a an ei leh in ang an ei phak loh bakah mutbu ḥtha pawh an nei lo chunga an in lam an ngai em em ḥthin kha mak kan ti ḥthin a ni. Mahse nu leh pa, thinlung zawng zawnga

hmangaiha, ngaihsaktu an nei tih an thinlungin a hre chiang a, an bul thlen thuai an nghakhlel thin a lo ni. Kut thap tak pawh ni se nu leh pa hmangaihna kuta kuangkuah kha nuam an ti a, an thla a lo muang em a lo ni. An chhungkaw ihmangaihna leh nun hlimna khan hmuu theih loh hruiin a lo thlung ngivet tlat mai a ni tih hriat chuan an haw châk em emna chhan kha âwm reng a lo ni. Chhungkaw dinhmun hnuaihnung tak pawh ni ila

'Duh loh nena buh-changrum ei ai chuan duh tak nena Bahra laih a nuam zawk' tih hi a la dik a, Lal Isua neitu chhungkuaah chuan harsatna hian chhungkaw nun a tichhe zo lo a, a tipung zawk fo a ni.

School building leh Compound nuam tak pawh thlahlel lovin School naupang chuan hmanhmawh em emin, ipte lêng dawr dawrin an in lam panin an tlan a, hmanhmawh takin in chhungah an tlan lut a. Nu leh pa emaw, pi leh pu emaw an lo awm tih an hriat chuan an ei tur an ei sawk sawk a, ipte thuthlengah an dah mai a, hlim em emin kawtlai lamah infiam turin an chhuak leh a.

An sawi tam lo, an nu leh pate an be ruai lem lo; mahse, an thinlung erawh chu a thlamuang tih a hriat ngawih ngawih si. Kan fate kan in chhungah an thlamuang em aw? Zanah nu leh pa bula tui em ema an han mu vang

vang mai te hi a man a tam ngawt asin. Kan ṭawngkam leh thiltihah kan fate hian hmangaihtu an mamawh. Thufingte 17:22 *'Thinlung hlim hi damdawi tha tak a ni a, thinlung lungchhia erawh chuan ruh a timawih thin.'* Thufingte 14:26 *Lalpatihnaah chuan rinna chak tak a awm a, A fate chuan inhumhimna hmun an hmu ang.*

1. Naupang kaih-hruaina tha zawk kan mamawh : Sapho leh Vaiho naupangte hi an rilru a puitling hma bik hle a. Kum li/nga aṭangin an mumal viau mai. Kum sawm chinah phei chuan puitling ang maia chhawr theih leh rilru puitling an tam tawh ṭhin. Mizo naupangte hi engati nge naupang rilru leh nun an put rei bik em em tih hi hnam pum kan inen ṭulna pawimawh tak niin a lang. Naupang anga kan cheibawl chhung a rei lutuk a ni em? Puitling tura inzirtirna leh kaihhruaina kan nei tha tawk lo a ni em? An tih theih tawka rin

ngam leh tih tur an kuta pek dan kan thiam a ɻul hlein a lang. Chhungkaw tinin hmasawnna tur kan nei ɻheuh tih hriat a va ɻha ve le. Naupang chu a kalna wm kawngah chuan zirtir ula, A upat hun pawhin a thlah lo vang (Thuf. 22:6).

2. Nu leh pa zah a pawimawh : Agape chanchinbu hi Thalaihoten an chhiar tlem hle a, nu leh pain an fate fuih nan an hman beiseein ɻalaite mawhphurhna hi han tar lang ila a ɻha ang.

Hmanlai kan Mizo pi pute nuna thil pawimawh tak chu nu leh pa thu awih, aia upa zah a ni a, hnam min tinghettu pawimawh tak a ni. Tunah chuan hnam dangin min chen pawlh NASA ta hle a, keini pawh mi ramah kan chhuak tam ta tawlh tawlh bawk a. Hengte avang hian kan ɻalaite nunah hian kan hnam nun ze hlu tak nu leh pa thu awih, aia upa zahna a lo tlahniam ta tial tial hi a pawi a, hnam ralna kawng pakhat a ni. Pathian thu

aang pawhin Pathian thu awih lohna zia a ni tih kan hmu bawk. Milem bia kan tihte hian an nu leh an pate an zahthiam hle ta zawkin a lang ta. Chuvangin, nu leh pate pawhin kan fate zirtir leh kaihhruainaah mawh-phurhna kan nei tih hre chunga kan fate awih thiam zawng taka zirtir hi kan mawhphurhna a ni.

3. Fanaute hi Lalpa laka kan rochan an ni (Sam 127:3) : Mizo mipui hi India ram mihring tamna aanga teh chuan kan la tlem hle a. Mahse, Mizoramah hian fahrah enkawlna leh ɻhalai kalsualte enkawlna Centre hi a tam hle a, State hrang hrangah mipui tam dan aanga tehin a percent hi a sang berin a rinawm. Kristian ram nih nen a inmawi lo a, a zahthlak khawp mai. Nu leh pate hian kan fate hi a enkawlnaah mawh kan phur a, thil dang chhuanlama mi dang kuta pek kan uar lutuk hi Pathian pawi sawina a tling dawn lawm

ni? Kan inenchian a țul ta hlein a lang. Lalpa laka kan rochante hi vanrama kan chhawm theih tur awm chhun an ni a, enkawl puitlin a pawimawh, khawvel thil dang hi chu vanrama chhawm luh tur eng mah a awm dawn lo a ni.

4. Zoram mamawh, Nu sakhaw mi : Tum khat chu Mosolman nu pakhatin a fa pi pu-ah a thēn a, a thēn paha a hla sak chu nau awihna hla sak satliah mai ni lovin '*Allah hi Pathian a ni, amah chauh hi pathian a ni, Mohammeda hi a zawlnei a ni*' tih hi a ni a. Vawi khat pawh Hindu inah kan riak a, nu berin zing

thawha a thiltih hmasak chu milem hmaa kuna, rintui hal a ni a, naupangte chu an tih theih tawk a tihtir ve bawk a. Naupangte sakhuanaa hruaitu pawimawh ber chu Nu hi an ni țhin. Kan fate '*Inkhawm rawh le, hei thawhlawm*' tih mai hi a tawk lo a, sakhaw thu hrilha, zirtira, kaihruaitu, hmahruairtu nih a țul a. Kan ram hian '*Kristian sakhaw nu*' a mamawh a ni.

Tâng vengtute khan Isua an rin avangin an chhungkua an hlim ta em em ang khan Isua hi chhungkaw hlimna khawpin ring ngam ila a va hlu dawn em! *Amen.*

He mi.... in phuarna hrui (*natna, drug, hurna, duhamna, etc.*)/kulh (*a rin dan, chapona, ngaih dan*) hi Lal Isua hmingin ka thiats e. 

Chutichuan, kan ram sualna leh rumna hi kan tu leh fate kan enkawl leh kaihhruai dan dik tawk loh vang ni mai lovin, a kaihhruai dan kan hriat loh leh thiam tawk loh vangte pawh a ni tel a, a ril em em a ni. Chuti chungin, nu leh pa thenkhat chuan a zir pawh kan peih lo va, a tum pawh kan tum peih hek lo hi, a pawi tak zet a ni.

Naupang enkawl hi thil har tawp, thapui thawh ngai a ni a, thapui kan thawh pawhin eng nge kan an ang, tih nak alaiin, thapui kan la thawh duh lo lehngthal hi chu setana tan chuan a hahdamthlak ngawt ta ve ang. Napoleon-a vek chuan, ‘*Sipai tha lo an awm lo va, hruaitu tha lo erawh an awm thei*’ a ti bawk. Nu leh pate hi kan inzir a tul tak meuh a, a chhan lian takah chuan, mihring hi enkawl ngai saa piang kan nih miau vang a ni, rante ang lo takin kaihhruai kan ngai a, pianpui tawng kan

nei lo va, zirtir ngai kan ni, pianpui mizia pawh min zirtirtu leh kaihruaitu azirin kan thlak mai thei bawk. Chu mawhphurhna chu nu leh pa te ko-a innghat a ni.

Chu chu a ni kan Bible chang tarlan I Samuela 1:20-23-ah khan kan hmu a, Elkana leh a chhungte chu an kum tin dan ṭhulh an hreh em em inthawina hlan turin an kal chho ṭhin a, chhungkua an kim ngei ngei ṭhin; mahse, Hani chuan, '*naute hnute hnek ban hunah*,' a tih tlat mai, thil dang a ni lo, Samuela'n a lo puitlin hunah Lalpa rawng bawla ram roreltu ṭha a nih theih nan a nu-in kalsan a rem lo va, a enkawl leh kawng a sah hmasak a ṭul tlat. Pharaoa fanuin chhiahhlawh leh nau

awmtu ngah hle mah se, Mosia chu '*Hruaitu Ropui*' a lo nih theih nan, Pathianin a naupan laia awm turin a nu a thlang tlat a ni, mi dang kuta dah chi an ni lo. Thu tha, Pathian thu hrilh tam in, kawng dik i kawhhmuh ang u; tah chuan, an lo thanlen hunah kan ram hi a dam leh ang a, Lalpa a ropui ang. Ar thial ei tura induhsakna pawh an inhauhna na ber a nih chuan chu chhungkua chu an inhau dawn lo a, induhsakna leh ihmangaihna chu an chhungkaw nunphung tur a ni dawn a, a va nuam dawn em tih min ngaihtuahtir hle a. Hetiang chhungkua hi Kristian chhungkaw zia chu a ni a, kan ramah hian kan awm ang em aw tih min ngaihtuahtir hle mai.

Cachar Tlangrama Winchester School-a ka thawh laiin kan Hostel naupangte chu kan theih ang tawka tha leh duatin enkawl vein kan inhria a. Mahse, School chawlh veleh hian hmanhmawh tak maiin an haw ḥthin a. An in leh lo chu a ḥtha lo ve hle a, hostel-a an ei leh in ang an ei phak loh bakah mutbu ḥtha pawh an nei lo chunga an in lam an ngai em em ḥthin kha mak kan ti ḥthin a ni. Mahse nu leh pa, thinlung zawng zawnga

hmangaiha, ngaihsaktu an nei tih an thinlungin a hre chiang a, an bul thlen thuai an nghakhlel thin a lo ni. Kut thap tak pawh ni se nu leh pa hmangaihna kuta kuangkuah kha nuam an ti a, an thla a lo muang em a lo ni. An chhungkaw ihmangaihna leh nun hlimna khan hmuu theih loh hruiin a lo thlung ngivet tlat mai a ni tih hriat chuan an haw châk em emna chhan kha âwm reng a lo ni. Chhungkaw dinhmun hnuaihnung tak pawh ni ila

'Duh loh nena buh-changrum ei ai chuan duh tak nena Bahra laih a nuam zawk' tih hi a la dik a, Lal Isua neitu chhungkuaah chuan harsatna hian chhungkaw nun a tichhe zo lo a, a tipung zawk fo a ni.

School building leh Compound nuam tak pawh thlahlel lovin School naupang chuan hmanhmawh em emin, ipte lêng dawr dawrin an in lam panin an tlan a, hmanhmawh takin in chhungah an tlan lut a. Nu leh pa emaw, pi leh pu emaw an lo awm tih an hriat chuan an ei tur an ei sawk sawk a, ipte thuthlengah an dah mai a, hlim em emin kawtlai lamah infiam turin an chhuak leh a.

An sawi tam lo, an nu leh pate an be ruai lem lo; mahse, an thinlung erawh chu a thlamuang tih a hriat ngawih ngawih si. Kan fate kan in chhungah an thlamuang em aw? Zanah nu leh pa bula tui em ema an han mu vang

vang mai te hi a man a tam ngawt asin. Kan ṭawngkam leh thiltihah kan fate hian hmangaihtu an mamawh. Thufingte 17:22 *'Thinlung hlim hi damdawi tha tak a ni a, thinlung lungchhia erawh chuan ruh a timawih thin.'* Thufingte 14:26 *Lalpatihnaah chuan rinna chak tak a awm a, A fate chuan inhumhimna hmun an hmu ang.*

1. Naupang kaih-hruaina tha zawk kan mamawh : Sapho leh Vaiho naupangte hi an rilru a puitling hma bik hle a. Kum li/nga aṭangin an mumal viau mai. Kum sawm chinah phei chuan puitling ang maia chhawr theih leh rilru puitling an tam tawh ṭhin. Mizo naupangte hi engati nge naupang rilru leh nun an put rei bik em em tih hi hnam pum kan inen ṭulna pawimawh tak niin a lang. Naupang anga kan cheibawl chhung a rei lutuk a ni em? ngam leh tih tur an kuta pek dan kan thiam a ɻul hlein a lang. Chhungkaw tinin hmasawnna tur kan nei ɻheuh tih hriat a va ɻha ve le. Naupang chu a kalna wm kawngah chuan zirtir ula, A upat hun pawhin a thlah lo vang (Thuf. 22:6).

2. Nu leh pa zah a pawimawh : Agape chanchinbu hi Thalaihoten an chhiar tlem hle a, nu leh pain an fate fuih nan an hman beiseein ɻalaite mawhphurhna hi han tar lang ila a ɻha ang.

Hmanlai kan Mizo pi pute nuna thil pawimawh tak chu nu leh pa thu awih, aia upa zah a ni a, hnam min tinghettu pawimawh tak a ni. Tunah chuan hnam dangin min chen pawlh NASA ta hle a, keini pawh mi ramah kan chhuak tam ta tawlh tawlh bawk a. Hengte avang hian kan ɻalaite nunah hian kan hnam nun ze hlu tak nu leh pa thu awih, aia upa zahna a lo tlahniam ta tial tial hi a pawi a, hnam ralna kawng pakhat a ni. Pathian thu

aang pawhin Pathian thu awih lohna zia a ni tih kan hmu bawk. Milem bia kan tihte hian an nu leh an pate an zahthiam hle ta zawkin a lang ta. Chuvangin, nu leh pate pawhin kan fate zirtir leh kaihhruainaah mawh-phurhna kan nei tih hre chunga kan fate awih thiam zawng taka zirtir hi kan mawhphurhna a ni.

3. Fanaute hi Lalpa laka kan rochan an ni (Sam 127:3) : Mizo mipui hi India ram mihring tamna aanga teh chuan kan la tlem hle a. Mahse, Mizoramah hian fahrah enkawlna leh ɻhalai kalsualte enkawlna Centre hi a tam hle a, State hrang hrangah mipui tam dan aanga tehin a percent hi a sang berin a rinawm. Kristian ram nih nen a inmawi lo a, a zahthlak khawp mai. Nu leh pate hian kan fate hi a enkawlnaah mawh kan phur a, thil dang chhuanlama mi dang kuta pek kan uar lutuk hi Pathian pawi sawina a tling dawn lawm

ni? Kan inenchian a țul ta hlein a lang. Lalpa laka kan rochante hi vanrama kan chhawm theih tur awm chhun an ni a, enkawl puitlin a pawimawh, khawvel thil dang hi chu vanrama chhawm luh tur eng mah a awm dawn lo a ni.

4. thawha a thiltih hmasak chu milem hmaa kuna, rintui hal a ni a, naupangte chu an tih theih tawk a tihtir ve bawk a. Naupangte sakhuanaa hruaitu pawimawh ber chu Nu hi an ni țhin. Kan fate '*Inkhawm rawh le, hei thawhlawm*' tih mai hi a tawk lo a, sakhaw thu hrilha, zirtira, kaihruaitu, hmahruairtu nih a țul a. Kan ram hian '*Kristian sakhaw nu*' a mamawh a ni.
