Chhim lama Kohhran mi tlem tê kan awm lai chuan chhangchhe bawngbawrin kan inkhawm thin a, zan lamah phei chuan tlar hnung lam thutthleng âwlah naupang an mu phung thin. Inkhawm bân rualin mahni fate theuh kan chuh sang sang a, pa hnung a awl thei bîk lo va, puak leh kaih fâwmin Biak in kan chhuahsan diah diah a. Biak ina naupang awm dâñ chu eng ang pawh ni se nu leh pa mualphonaa ngaih a ni lo va, harh mang lova in thlenga kan inkaih dawt dawt pawhin 'hetiang châng hi chu a awm ve fo a nia,' tiin inkhawm thulhna thama ngaih a ni ngai rêng rêng lo.

Kohhran hmasawnna hian naupang tel lova inkhawm a keng tel ta em ni aw! Biak ina naupang a tahan nu leh pate'n zahthlakah kan ngai a, fate vanga mi zinga mualpho hlauh vang ringawtin fate kan inkhawmsan a, tlema an leikân deuh chuan Biak in chhûng thleng khât zâwngin naupang inkhawm lamah an inkhawm leh daih a. Kohhran hmasawnna hian Biak inah naupang a len lohtîr chho zel a nih chuan pawi kan la ti ngei dawn a nih hi. Chu chang a ni lo, khawvel hmasawnna hian kan in chhungah naupang hmuh leh hriat duh zawng thil tam tak min chhawpsak tawh a, inkhawma kan hruai loh hian an tân a hrehawm hran lo va, nu leh pa awm loh hlana ina awm hi tunlai naupang tân khawharthlak a ni tawh rêng rêng lo.

Engtin nge kan tih ang? Kohhranhote hian Biak ina chhangchhiat kan zir thar leh a ngai tawh a ni lo maw? Biak in hi thalai leh nu leh pate inkhawmna tur chauh ni lovin naupangho inkhawmna hmun tur pawh a ni tih kan hriat thar a tul ta. Kan faten Biak ina inkhawm an châk loh pawhin kan hruai luuh tlat a ngai a, naupang an nih hre chungin ngaihnathiamna thui tak i nei bawk ang u. Kohhranho infuihna leh intuaitharna hian naupang a thlen phâk loh chuan 'a tlai lutuk hun' kan la thleng ang a, Biak in thleng ngai lo naupang chu a tleirawl hunah Biak in lam hawitîr a khirh talh mai thei! Biak in hi chhangchhe bâwmah siam thar leh ila, an phak tawk a nih miau avangin an bengchheng deuh pawhin i hrethiam ang u. Kan tu kan fate hi Biak in leh a vêlah tlângnél rawh se. Biak in chhûng Kohhranho an bengchhen deuh chuan 'kohhran nung tihna' an ti thin a nia! (CTK)

Râl Vêngtu chuan mite hnenah chuan, "Engtizia nge tûkina takin in lo thut nghûk mai le? Hlauh nei ang maiin in tang deuh hrû hlawm leh nghâl a," tiin a zâwt a. Mite chuan, "Niminah mikhual an lo thleng a, Pu Ralția te inah an thleng a, nizan khan an thlen inah Pathian thu ngaithla turin khuaa mite min sawm khawm a. Sakawlh hlauhawmzia te, Kohhrana hming ziah a him lohzia te, Ration card-a hming ziah a pawi theih dan te leh chhungkaw hming ziah a ngaihna rêng rêng chu lo hnigmhnai lo turin min hrilh a; kan Halelui nasa mai maw le!" tiin an chhang a.

Mahni mihring puite tana tha tur a nih dawn phawt chuan ringtute chu chawljni a ni emaw, ni lo emaw kan phe lawp lawp mai tur a ni zawk dawn lawm ni?*

Presbyterian Church of India Thirun IX-naah chuan, "...Lalpa Ni serh thianghlim te, Amah be ho tura inkawm te, A thu hril ngun takin ngaihthlak te..." tiin Pathianni serh chungchang kan hmu a. Kristian Nun Kaihruaina, Kristian Nun - Sakhaw lam (2)-ah chuan, "Ringtu zawng zawngeten Pathianni an serh tur a ni. Khawvel hna tih lawk theih leh ni danga tih theih - lei leh zawrh te, thu pawimawh dang sawi te tih loh tur a ni. Hahchawlh nan hmanga mut bo nan leh mahni chakkhai lam nana hmang lovin, Pathian biak nan leh a thu ngaihthlak nan te, an thlarau tana sâwt tur apiang tih nan te an hmang tur a ni," tih a ni bawk.

I rawn sawi ang deuh hian doctor te, sipai te, police te, etc. hi han chawl thup mai selang chuan a buaithlak viauin a rinawm. Hei hi Kohhran pawhin a hriat avangin Pathiannia mahni hna tula kalte pawh ngaihhnathiamna thui tak a nei a, zawldawh takin Kristian Nun Kaihruaina lamah pawh tarlan a ni. Duty tul avang te, dam lohna avang te, chhiatna avanga inh mang te leh Pathiannia exam ngai tlatte chungah pawh Kohhranin thununna a lek hriat tur a vang khawp mai. Amaherawhchu, ringtu chuan Pathianni a ngai pawimawh tur a ni a. Duty thin nih avanga mahni hman niah pawh inkawm lova hahchawlh nana miin a hman chuan a tan sual a tling thung ang. Mahni inhmakhu theih chin chinah chuan a inhmakhu ang a, Pathian leh a mihringpuite lakah pawh a intiam theihna tur leh mi dang mit pawh timîm lo zawnga a awm theih nan, loh theih lohnain a tlakbuak a nih chauh loh chuan Pathianni a serh tur a ni. Engpawh nise, Kristian pangngai chuan Pathian laka intiam chin leh intiam loh chin a nei mai thin a, Johanan, "Duh takte u, kan rilruin thiam loh min chantir loh chuan Pathian lamah kan huai a ni," (I Joh. 3:21) a tih ang hian Pathian lama kan huai theih nan kan rilru pawhin thiam min chantir theih tura kan nun a pawimawhin a lang.

Mizoram Social Front chuan May ni 2, 2012 khan Synod Conference Centre-ah Ruihhlo dona kawnga chak zawka hma lak dan tur inrawn khawmna a buatsaih a, khawpui chhung Presbyterian Kohhran Social Front Committee Chairman leh Secretary theuhte bakah CYMA, Mizoram Excise & Narcotics Department te sawm an ni a, mi 180 zet an kal khawm.

He inrawn khawmna hi Rev. Lalzuithanga, Executive Secretary-in a kaihruai a, thu zir ho tura buatsaih (*concept paper*) zir ho a nih hnuah inrawn khawmna neih zui a ni. Mizoram Presbyterian Kohhranin thalaite rilruah ruihhlo mamawhna a bo theihna tura inzirtirna chi hrang hrang a lo kalpui tawh dan te; camping, seminar leh workshop te buatsaih thin a nih thu te tar lan a ni a. Ruihhlo vanga buaite tan Rescue Home siamin mi tam tak an enkawt tawh bawk a ni.

Mizorama ruihhlo hluar chho zel titawp tura beitu pawl hrang hrangte tha tichak turin Mizoram Presbyterian Kohhran chuan a theihna lai laia lo tan ve chu a tih tura ngaiin Synod 2011 khan Ruihhlo dotute tha tichak zawnga hma lak a rel a, vawiin thleng hian heti lam zawng hian tha a thawh chho ta ngar ngar a ni. 


