Chuvàngin, innghahna him leh him lo te, dik leh dik lo te, tha leh tha lo te, nghet leh nghet lo te, belhchian dâwl leh dâwl lo te, rin tlâk leh tlâk loh te, fiah dâwl leh dâwl lo te a awm thei hle ang.

Lal Isua khân mi fing, lungpui chunga in satu leh, mi â, tiauvut chunga in satu chungcháng a sawi a (Mt 7:24-27). Tripura Mission Field-ah Mizoram Synod-in Official-a rawng a bawl tan hun, kum 1986 atangin vawiin thlengin harsatna, lawmnna leh hmasawnna a dawn sawi tur a tam hle a.

Kum 2017 atangin Provisional Synod hial kan lo thleng thei hi Pathian malsawmna kan dawn a ni. Nakum 2019 kum tir lamah khian PCI General Assembly chuan Synod Puitling (*Full Fledged Synod*) dinhmunah min hlan kai kan beisei mek a ni.

April 5, 2018 khán Mizoram Synod leh Tripura Synod OM member-te chuan Tripura rama rawngbawl dun zel dan tur, inremna thuthlung fel tak an siam a. Inremna angin Mizoram Synod chuan kum nga chhung Tripura Field-ah hian rawng a bawlpui phawt ang a, chumi hnuah kal zel dan tur chu en that a ni ang.

Chuvangin, Provisional Synod dinhmunah siam ni tawh mah se Synod Mission Board (SMB) chuan rawng kan la bawl zui zel a. Hemi chhung hian Tripura Synod chu mahni kea ding thei tura a lo inchher hriam ve a ngai dawn a ni. Tripura Mission Field hi Mizoram Synod-in SMB hmanga mission field a neih tawh hote zingah chuan rawngbawlna kawnga a hlawhtlin berna zinga mi a ni a.

Tripura Field-ah hian SMB chuan rawngbawlna hmanrua hrang hrang: School, Medical, Craft Centre leh *direct evangelism* hmangin rawng a bawl ber a. Hmun khatah ringtu an lo punin *fellowship, preaching station* leh kohhran te a din zel a. Tuhnah hi chuan Tripura ram pumpui deuhthaw dap chhuakin kohhran kan nei tawh a ni. 2017 inchhiarnaa a lan dandin Presbytery pali neiin, kohhran member 22,277 (dan zawhkim 15,055) lai kan nei ta a. PCI General Assembly hnuai Synod 10 zinga pali chu member-ah kan khum nghal a ni. Chutih rualin,

Tripura Synod hi Mizoram Synod ṭanpuina tel lo, mahni kea ding thei tür chuan kan beih fē a la ngai ang.

Chuvàngin, kan intodelhna tür kawng zawngin kan bei mék a ni. Tripura Synod member-te hi thawh hona kawngah kan inlungrial a, a ram mite leh missionary-te pawh induhsak tawn takin nihna leh chanvote kan inkian thiam êm êm a. Hetianga inrem taka kan thawk ho reng thei a nih chuan intodelhna leh puitlinna kawngah pawh kan hlawhtling chho zélin a rinawm. Chuvàng chuan thawktute, a bik takin missionary-te chuan a ram mite thawhpui thiam tür leh an thâ tichak türin ṭan kan la mék a ni.

Kum 25 zet Communist Party-in Tripura ramah ro an rèl chhúng khán rawngbàwlna lamah harsatna lian kan tâwk ngai lo. Kumin 2018 February thla aṭang khán BJP chuan sawrkarna an chang ve ta a. Ram páwn lam aṭanga thlirnaah chuan kristianten dodàlna kan tawh hlauhthawnpuina a nasa hle a. Nimahsela, tûn hma ang thovin Lal Isua Chanchin Ṭha hrilna kawngah kan thawk zui zêl a. Kan rawngbàwl dàn kalhmang pawh thlák chuang miyah lovin *programme* kan la siam mék a. Ringthar *baptisma* chantír kawngah pawh venthàwn nei lovin a chang duh apiang kan la chantír chhunzawm ta zêl a ni.

Tripura ramah hian rawngbàwlna tür a la tam hle a. Kum 2011 chhiarpuiā khán Tripura mihring hi 36,71,032 anga ngaih a ni a. Chutah chuan 60% chu Bengali niin, a bâk 40 % chu tláng mi hnam hrangte an ni. Kristian hi 3.2% (1,17,473) vél chauh kan la ni. Chuvàngin, rawngbàwlna tür hmabâk a la tam êm êm a. Dodàlna awm lovin zalèn takin Isua Chanchin Ṭha kan la hril thei a, a làwmawm hle a ni. Tripura ram hi Mizoram nèn inkalpawhna a ṭha sâwt viau a. Chuvàngin, kan thâ thlah lovin kan kohhran hian Tripura ramah Pathian Ram i zauh zêl ang u.

**SERMON****KRISTA CHANCHIN THA***Chhiar tür: Marka 16:15-16*

Mk 16:15-16-ah chuan Isuan Chanchin Tha hril türin a zirtirte thu a pe a. Chu Chanchin Tha chu tute emaw hnênah chauh hril türin thu a pe lo va; mihring chauh huamtír lovin, thil siam zawng zawng hnêna Chanchin Tha hril türin a thu a pe zâwk a. Chu Chanchin Tha ringtu apiang chu chhandam an nih tür thu sawiin, a ringlote chu thiam loh chantir an ni ang, a ti.

He Chanchin Tha hi kohhran tiak tir khân a hril nghâl a. An hun laia an khawvél hriat chinah Isua Krista Chanchin Tha chu an hril a, a remchâンna hmun apiangah kohhran an din a. Isua Krista chanchin chu an hril a, tihduhdahna leh nèkchêpna kárah pawh an zâm lo. Paula phei chuan, “*Chanchin Tha chu ka zahpui si lo va; tu pawh a ring apiangte tân chhandamna tûra Pathian thiltihtheihna a ni si a,*” a ti hial a ni (Rom. 1:16).

A nih leh, he Chanchin Tha, Isuan thil siam zawng zawng hnêna hril türin min tih, a ring apiangte tân

chhandamna tûra Pathian thiltihtheihna chu eng nge ni ta ngai le?

Chanchin Tha, Sâp տawnga ‘Gospel’ an tih hi Grîk տawng chuan *euangelion* a ni a, chumi awmzia chu chanchin tha, lungchhiat-thlák leh thinrimna thu ni lo a ni a. Sâp տawng - Gospel pawh hi Sâp տawng ùn, *godspel* tih aṭanga rawn kal a ni a, chu chu *good news/story* tihna a ni. Mizo տawnga Chanchin Tha kan tih ang bawk hi an koh dàn a ni a. Eng vànga Chanchin Tha lo ni ta nge? Chu Chanchinah chuan mihringte chhandamna thu, Pathian thinùrna lak ata chhuahna

thu, saltâng chhuahna a awm vàng a ni. He Chanchin Thaah hian Isua Krista kal tlanga Pathian khawnghaihna a awm. Chanchin Tha chhúnga thil awmte hi pathumin a sawi theih.

### **Thu dik rin tûr chu:**

Chanchin Tha chhúnga thil awm pakhat chu thu dik rin tûr a ni. Chu thu dik, rin tûr zínga pakhat chu ‘Krista chu kan sual aiin a thi’ tih hi a ni. Krista chu kan sualte avângin Pathian lehkha thu angin a thi a ni tih Paula pawhin chiang takin a tár lang a (1 Kor 15:3). Mi fel tu mah kan awm lo va (Rom 3:10), mi zawng zawng hian thil kan tisual tawh vek a (Rom 3:23), chu sualnain a hrin chu thihna a ni (Rom 6:23). Kan sual avângi thi tûr kan nih laiin, kan thih aiin Isua a thi a ni.

Kan rin tûr thu dik, thil thleng ngei, phuah chawp satliah ni lo chu – ‘Krista chu mitthi zíng ata a tho leh’ tih hi a ni. Paula pawhin thawlehnna thu a thusawi bulpui berte zíngah a nei a, Petera thu sawi hmasa

berah pawh thawlehnna thu hi a langsâr ber páwl a ni (Tirh 2:22-23). Krista chu mitthi zíng ata a tho leh ngei a ni tih mi tam takin an hmuin an hria a ni (1 Kor 15:5-8). Eng vànga tho leh nge? Thiam kan channa tûrin mitthi zíng ata a tho leh a ni (Rom. 4:25).

Isua chu a tho leh ringawt lo va, a thawlehnna chuan hming zawng zawnga hming chungnung ber pêk a ni a, Pathianin nasa takin a chawimawi a (Phil 2:9-11). Kaihthawha a awm hnu chuan engkim chungah Krista chu a awm a (Eph 1:20-23), thuneihna leh thiltihtheihna zawng zawng chu a ta an ni ta a (1 Pet 3:22), he khawvêla roréltute chungah Pathian chuan a dah a ni (Thup. 1:5). Vánah, chawimawina ropui nèn ro a rèl hnuin, he leiah hian a ropuina nèn a rawn kal leh dawn, tih hi phat rual a ni lo. A vântirhkohte ngeiin a zirtirte hnênah a rawn kal leh tûr thu hi an sawi a (Tirh 1:10-11), amah ngeiin kan tána hmun a siam zawh hnua a lo kîr leh tûr thu a

sawi bawk (Jn 14:3). Chumi hunah chuan amah ringtute chu a chawimawi ang a, amah ringlotute chungah chuan hrehawmna a thleng ve thung dawn a ni (2 Thes 1:7-10).

### **Thupék âwih tür chu:**

Isua Chanchin Ṯhaah hian thupék, âwih ngei ngei tür a awm a. Thupék chu kan âwih chuan chhandamin kan awm ang (Mk 16:16). Chu Chanchin Ṯha chu a ring apiangte tána chhandamna tûra Pathian thiltih-theihna a ni (Rom 1:16). Chanchin Ṯhaa thupék awmte chu eng nge? Chhandam kan nih theih nána kan tih tür chu eng nge? A chunga kan tar lan, thu dikte khi ringa pawm mai tür a ni - kan sual aia Krista a thih thu te, a thawhlehna te leh ropui taka a lo kal lehna tür te rin hi.

Krista Chanchin Ṯhaa kan tih tür hmasa *pakhat chu kan* "...kain Isua chu Lalpa a ni tih kan tan a, mitthi zíng ata Pathianin a kai tho tih kan thinlunga kan rin chuan chhandamin

kan awm ang" (Rom 10:9). Ethiopian mi tilreh pawhin a kain a tan a, a thinlungin a pawm a, chhandam a ni a (Tirh 8:37). Amah kan rinna hi kan puan chhuah chuan, Isua pawhin Pa Pathian bulah min tan ve dawn a ni (Mt 10:32-33).

Isua kan ringin kan pawm a ni tih kan lantir hnu chuan a la tâwp mai, tih tür, thupék âwih tür kan la nei cheu, chu chu sual sim a ni. Simna leh sual ngaihhnathiamna thu hi Isua pawh khân a ngai pawimawh hle a. A thawhleh hnu khán a zirtirte hnênah he thu hi a sawi nghe nghe a nih kha (Lk 24:46-47). A zirtirte pawhin he thu hi an ngai pawimawh a, Peteran a thuhril hmasak ber tuma a sawi pawh sual simna thu hi a ni (Tirh 2:37-38; 3:19). Paula pawhin Jentailte zinga a thuhril langsär ber pakhat chu sual simna thu bawk a ni (Tirh 17:30-31).

Kan sual kan sim loh chuan kan boral dawn a ni tih Isua ngeuin min zirtir a ni (Lk 13:3). Sual sim hnu

chuan, kan sual ngaihdamna tûrin baptisma kan chan a ngai. Isuan, “*A ringa baptisma chang chu chhandamin an awm ang,*” a ti (Lk 16:16). Petera pawhin, “*Sin ula, in sual ngaihdam nán Isua Krista hmingin baptisma chang theuh rawh u,*” a ti bawk (Tirh 17:30). Sual sima, lal leh chhandamtua Krista kan puān hnu chuan inthlah-dah a thiang tawh lo va, thih tlenga rinawm tûr a ni

### **Dawng tûra thutiam:**

Krista Chanchin Tha kan hriata, kan pawma, chu Thu dik chu kan tan chuan, sual ngaihdamna kan chang a (Tirh 2:38), kan sualna thai bo a ni ang a (Tirh 3:19), a thisenah chuan tlan kan ni ang (Eph 1:7) a, Krista thisen chuan kan sual zawng zawng tlen fai a ni ang (1 Jn 1:9). He sual ngaihdamna hi a hlu a, sual ngaihdama a awma, Pathian laka thiam chang kan nihna tûr hian Israel fate chu kum sâng chuang beràm thisen hmangin an inthâwi a; mahse, an thei si lo a nih kha.

Krista Chanchin Thaah chuan pêk tûr thutiam dang a la awm cheu va, chu chu Thlarau Thianghlim thilpêk a ni. Chu Thlarau Thianghlim chu sual sima, baptisma changte hnênah thlentíra, pêk thin a ni a (Tirh 2:38-39). Chu Thlarau avâng chuan kan nung ang a, kan taksa thi theite chu a tinung dawn a ni (Rom 8:10-11). Thlarau tel lo chuan mihring chuan Pathianah nunna a nei dawn lo. Chu Thlarau, kan nun theihna tûr chu pêk min tiam a, min pe mêt a ni. Chu Thlarau chu kan chhûnga a chèn hnu chuan keimahni aṭangin nuna thil tha ber ber a lo pár chhuak ang a (Gal 5:22-23), chu Thlarau avâng chuan mihring chuan chakna a lo nei thei thin a ni (Eph 3:14-19).

Chanchin Thaa thil awm pawimawh tak mai pakhat chu Chatuan nunna pêk tiam a ni. Chatuana nun hi mi tam takin an zawng a; mahse, chu nunna chu khawvél thil leh ngaihtuahna lama awm

ni lovin, Chanchin Tha huang chhúnga neih tür a ni a, amah chu a ring apiangin chatuana nunna chu an nei dawn a ni (Jn 3:16).

Krista Chanchin Tha chhúnga lüt tür chuan Thu dik, khawvél miten ring-hlela dâwt nihtír an tum thin chu kan pawm a ngai

a. Chu mi pawm ngawt bâkah chuan thupék âwih tür min pe a. Krista Thu dik leh a thupék te kan âwih chuan kan sual thai bo a ni ang a, Beràm No thisena bualin kan awm ang a, Thlarau Thianghlim min pe ang - chatuana nunna nèn.

Hei hi Krista Chanchin Tha chu a ni.

Nimahsela, keimahnii emaw, vàn aṭanga lo chhuk vàntrirkoh pawhin emaw, Chanchin Tha kan hrilh che u lo kha chu Chanchin Tha dang rēng lo hrilh che u sela, anchhe dawngin awm rawh se. Hun rei tak chhûng Arunachal (Changlang district) leh a chhehvêl (Assam)-ah kan insâwr bing a. Uluk taka kan hotuten an zir chian hnuin Kohhran than zêlna atân leh Lal Isua Chanchin Thain hmun tam zâwk a thlen zêl theih nân kum 2016 atangin kan la luh ngai lohna *district* hrang hrang paliah thawktu indahin kan puan in kan zauh a.

Kan rawngbâwlina hnam pui ber (*main focused group*) pawh *Tangsa* mai ni tawh lovin *Mishmi* an ni tel tawh a ni. *Mishmi*-ah hian hnam pêng lian pathum- Idu, Miju leh Digaru *Mishmi* te an awm a. **Lohit tui luang kianga Kohhran phun chu!:** China rama Zayu lui lian tak chu India ramah rawn luang thla zélin, Arunachal tlângram chhêngchhe tak mai chu Km. 200 lai a rawn pal tlang a. Chumi hnuah phaizâwl (Arunachal ram chhung si) chin a rawn thlen chuan 'Lohit' tia sawi a lo ni tawh a. A kuang a zauvin, hmun thenkhatah phei chuan a luang kâk (pherh) sung mai a. Tlâng chhîp atanga thlir phei chuan mawi tak a ni.

Chu Lohit lui kam phaizáwl rem tak maiah chuan kum 1946-a din - Tezu khawpui chu a awm a; Lohit *district headquarters* a ni. Kum 2011 chhiarpuiah khân mihring 18,184 awmin, chûng zînga zâa 75.57 chuan an puithùna chikim nèn an pipu sakhua la vuanin an la inthâwi tluk tluk mai a; Hindu-ho lahin fing takin Hindu sakjaw betu-ah an rín lüt mék bawk. Kristian hi zaa 8.24 awm anga târ lan a ni a, hêng zîngah hian a ram mi dik tak (Mishmi) an awm meuh lo. Chutiang hmunah chuan kan aiawha ram enthlatuten luh an rawt ve mauh mai si a. Hmâna Paran thlalêra mipui pung khâwmin lunga den an tum ang kha kan ram enthlatute chungah thleng ve lo mah se a huphurhawmin, hlawhchham a hlauhawm duh ngei mai!

Tichuan, 2016 kum bul aṭangin thawktu pahnih indahin bul kan ṭan a. Theih ang angin member tûr an hui khâwm a. Member hmasate chu - kan Kohhran mi, *district* dang

aṭanga Tezu-a lehkha zira awm te, kan Mizo-pui, hnathawhna avâṅga awm te, naupang tê an nih lai, kan *mission school* (Jeruel English School, Lakla Assam)-a an kal laia Isua ringa baptisma chang, rinawm taka lo Kristian ve ngar ngar unau pahnihé nèn mi tlém tê an ni.

Tichuan, Lohit lui kamah chuan kohhran chu kan han phun ta râwih a. Tezu aṭanga Km. 120 vêla hlaa awm, Jairampur bialah behtîr an ni a; *Field office* pawhin hmun thar a nih avâṅgin uluk takin min vilpui bawk. *Field* hotuten ṭahnem min ngaihpui a, kumin April thla aṭangin *Craft Centre* changtlung tak min dinsak a. Tûnah hian puan ṭhui zirlai pariat kan nei a, hêng zînga pasarih chu pipu sakjaw vuantute an ni.

Hêngte leh thawktute inpêkna avâṅgin mi hriat kan hlawh ṭan a, hma pawh kan sâwn ve bek bek. Theih tâwpin, fimkhûr leh uluk tak siin; tum dàn bîk (*strategy*) mumal tak neïn Lohit li thûk sangha man tumin thawk-

tuten ṭan an khawh a; mahse, li thûk sangha erawh man an lo har phian mai. “*Eng tikah nge a ram mi (Mishmi) dik tak, kohhran bul ṭan tak taktu tûr ringthar kan neih ang?*” tih hi kan thawktute rilru kap fotu a ni.

**Li thûk thim chu!:** Kan thawktuten Chanchin Tha chaw-chah chu an han chah ta vang vang a. Mahse, li chhúng erawh a lo thim ngang mai a; ei tûr chu rawn hêl ṭhîn mah se, an ei hlei thei dêr lo. An nun chu inthâwiin a khat a: chhúngkua thlamuang leh hmuingil taka an awm theih nána thlarau tlâwnna inthâwi (*tanu*) te, mitthi thlarau tâna inthâwina (*de*) te, an puithiamte puala inthâwina (*tajanpu*) te, mitthi sâwngbâwl inthâwi-na (*talo*) te leh khawtlâng huapa inthâwina (*namsang*) te hi a lâr zualte an ni. Hêng serh leh sâng an tih lai hian inthâwina in emaw, khuaah emaw mi dang lût leh chhuak an awm phal a ni lo. Hre lova an lo lût palh a nih chuan chhuah leh theih a ni lo. Inthâwina zawh hma chu (kâr khat lai pawh a ni

thei) awm ngàr ngâr a ngai a. He dàn hi *gena* an ti.

An thil neih, a bîkin an ran vulh zawng zawng hi inthâwi nán a zo zêl a, an sakhu hian a rawk a ni ber. Lohit District ȝhenawm Anjaw District-a an MLA pakhat chuan tûn hnai khân inthâwi lian tham tak siamin chêng nuai 30 vêl a sêng a. An puithiam thurâwn angin an chhúng-kuaa mahni inthahna thleng fo a lo reh theih nán, mahni intihlum tûra a tu leh fate tûr ṭhîntu, an pu ber thlarau hnawh bo nán he inthâwina hi buatsaih a ni a. Hetianga lian leh hautak hi vawi khat dang tih leh a la ngai a ni àwm e.

Mi tam ber hi awmze nei lo takin an nung a ni. Mihring nun hona leh inzâr zâwmna te, khawtlâng leh mi dang ngaih pawimawhna (*civic sense*) ten hmun a chang lo va; an nung ve tawp a ni ber mai. Sawrkar dânin an nunah awmzia a nei phâk vak lo. Anmahni chhúnga harsatna chu khawtlângin emaw, chhúng-kuain emaw rorélin an ching fel mai a. Mi dang pawi tawh

palh thulha lei an inchawitir  
thin chu tam turu tak a ni.

An fanuten pasal an neih dáwnin an man atán sial leh bungrua tam tak an phút a. An fanu in hrang changte nèn an inzâwm zél theih nán kum tin hautak tham khawpin an mâkpate thil an pe kîr leh réng thung a. Nun a hautak a, thih pawh a awlsam chuang lo.

*Idu Mishmi-ho phei* chuan mitthi kutah pawisa an humtîr tûn a, a kawr ipte zawng zawngah an hnawh puar a. Mitthi thlarau chu thlarau khawvêlah a lo intun nun ve nán chûng pawisa leh a thil neih hlu zawng zawng an phûm tel a; vawk emaw, ar emaw a nung chungin an phûm tel bawk thin. A tawi zawngin, nun an thiam lo va, thih an thiam lo hlei hlei. Hei bâk bâka thim thuah hnihil hi a awm chuang àwm lo ve!

### **Li thûk sangha chu le!:**

Hêng thimna hi ûm bova,  
Chanchin Tha ênga an nun chhun êng tûrin tih tûr a tam hle mai; mahse, thil awl-ai a ni si lo! Tezu-a kan

luh tirh aṭangin kan thawktute hian *Mishmi* chhúngkaw pakhat veh fâl hi an nei a. Chhúngkaw nu ber chu nu fel tak mai a ni a, *Miju Mishmi* an ni. A pasal chu hêng laia paho dang ang bawkin *Kânîngai* (*opium addict*), mahni nupuite thlazâr hnuai a nung ve mai mai a ni thung.

Nu ber hi lehkha thiam ni lo mah se, nu thluak tha zet a ni a. Hei vàng hi a ni ngei ang, khawsak pangngai tak niin, in leh lo pawh an nei tha a, in pawh an nei nual mai. Inthâwi leh serh leh sâng an khawihna in *Mishmi style*-a sak sei zet mai an nei bawk. Anni hi kan man thei a nih hlauh chuan an khawtlângah nghawng tha tak a nei ngei dáwna hriain kan *missionary*-ten thianah siamin an kawm tlângnêl a. Inkhâwm tûrin an sáwmin an tlawh fo bawk.

Kumin June thla aṭangin Pathianin an nu ber thinlung hi min hawnsak a, Kristian zirtîrnaah a tui ta viau mai a. Amah hi tha ná nei, a dam theih nán sum tam tak hmanga inthâwia lo

insêng ral tawh a ni bawk a. Hêngte avàng hian kan Pathianah rinna leh beiseina a nei thûk hle. Kan Kohhran inkhâwmah chuan *regular* takin a rawn tel ta a, a pasal pawh a rawn hruai ve thîn. Pathian thu a manin a tui hle a, a chîk hle bawk. Thuah a inchiah hneh viau a ni.

Mahse, a chhúngkaw *member* dang zawng zawngte nèn Kristianah an impe rual thei dáwn hrih lo tih a hriat avàngin a rilru a buai thîn hle. Kristianna leh sakhaw dang thil in khata tih kawp kha thil theihah a ngai lo bur mai a ni. Hei vàng hian a thiam ang angin a pasal fanaute rilru hmin tumin ṭan a la ve reng thîn a. Hetih lai (Baptisma a chan hma) pawh hian ruah sûr bûr bûr hnuaih pawh inkhâwm erawh a ṭhulh ngai hauh lo thung.

Thla hniih chhúng pelh lova inkhâwma, Tezu a thawktute mai bâkah *Field Gospel Team leader* leh mi dangte hnèn aṭanga thu leh ṭawngtaisakna an dawn mawlh mawlh hnuah vànnieithlâk takin an

nupaa baptisma chan an duh ta hlauh mai a! An fate nupa pawhin remchâng danga zui ve tûrin rilru an siam ta bawk a, kan lâwm hle mai. Baptisma chan hmain an in leh an inthâwina thil zawng zawng then thianghlim a duh thung a.

Hetianga tithei tûr hian nu ber hian an chhúngkaw ro lo rél fel hmasa vekin, July ni 26, 2018 khán an in leh a chhehvél chu Pathian tâna thian thianghlimin, an sakhaw/inthâwina hmanrua zawng zawngte chu tihbora a ni ta a ni.

Kan thawktuten Tezu an thlen tirha inthlahrung takâ lén an va dîlna in kha Lal Isua Chanchin Thain a luh chhuah hnuah chuan, chu in ngeiah chuan chu Chanchin Tha thlentu kan thawktute chu lêng tûra ngen an ni ta thung a. A tîra an bathlär bâk pelhtír phal lotute ngei khân an pindan chhúngril ber thlengin an luh loh hlauvin an kai lût a, “*Hetah pawh ṭawngtai tûr*,” an ti ta ruai mai a nih chu!

Tichuan, August ni 5, 2018 khân Tezu Preaching Station-a kan ringthar hmasa ber ni tûrin Pu Sochem leh Pi Guhuilu Polong te nupa chuan Bialtu Pastor kutah baptismal an chang ta a ni. An fate nupa leh an tute pawhin remchâng hmasaah an chang leh thuai tûrath kan ngai bawk.

Hemi nia Kohhranhote lâwmzia leh hlimzia kha theihngihilh a har ngawt ang le! Tezu Kohhran member mai bâkah, *field chhúngá* thawktu zawng zawngte kan lâwm a, baptismal chang lai hriatpui tûr hian kan *Field Secretary* leh rawngbâwl-pui ṭhahnem tak hmun hla tak aṭangin an rawn kal vang vang hlawn a ni. A mawh love, Lohit li thûk sangha lian kan man miau alâwm le!

**A hnah pawh uai ngai lo?**: Hêng kan tarlante leh thil tam tak avângin Lalpan Lohit lui kam ram tha tak hi min pe dáwn tak tak niin ka ring ngam a, kan phûr tlâng hle. Chutih rualin, bul kan tan chauh a ni a, hma bâk tih tûr a kó khawp mai.

Tûnah chuan kan inkhâwmna - thawktu *quarters*-ah pawh kan leng ta mang lo.

Kan *Mission Board* zârah ram/Biak In hmun tha tak kan nei tawh a. Chutah chuan *quarters* pakhat kan sa zo tawh bawk a, Biak In sak theih hun a nghahhlelhawm hle. Tezu leh kan hmun thar dangte hi pastor bial kan neih sate aṭanga a hlat deuh avâng leh a mi chêngte hi ṭawng leh ziaah an dan êm avângin Tezu Pastor bial thar hawna, hêng kan rawngbâwlna hmun tharhote a hran deuh leh uluk deuh taka enkawl theih a duhawm hle a ni.

Tezu Kohhran din tan dàn leh he hmuna Pathian hnathawh hrang hrangte hi tum khatah kan sawi vek séng lo. Eng pawh ni se, he Lohit tui luang kianga Kohhran phun, a hun taka rah chho ve mîk hi a hnah uai lova a than zéi theih nán theih tâwpin kan bei mîk a. Hemi atâna pawimawh ber - ṭawngtaia lo ṭang tûrin kohhranhote kan sâwm che u a ni e.

Ruah súr hnuaiah *chapal* pawh bun lovin min rawn zawng chhuak hlawl mai hi a lo ni a. An farnu chuan nautê (thla khat mi vê) a pawm a.

Eng mah damlohma emaw, insawisalna emaw a nei lo.

Mak tak maiin, nautê hnutê pea a mutpui laiin khum aṭangin a let thla tawp mai a. A meng râng nasa êm êm mai a, a melh ngai melh rùn rùn chungin a nui vak bawk a. Engkim ti theitu hming lamin kan ṭawngṭai a, Bible nèn kan nem bet lui a; a zâl ta ruai ruai mai a. Hetih lai hian damdawi ina awm vete leh *nurse-hoten* mak ti takin min lo hual ṭhup mai bawk a.

Chumi hnu-ah Bible chhiarin, kan ṭawngṭai leh a. Tichuan, ramhuaiin a chhuahsan ta a! Tui kan intîr a, dam takin a rawn tho chhuak ta a. Kan tî tî zui nghâl a, ṭha takin Pathian thuin kan kawm zui thei ta a.

Tui chu Pathian hnênah kan hlàn a, chu tui chuan In chhúng chu Isua hming lam zélin kan theh chhuak leh ta vek a. Kan theh bâng tui chu ṭhenawmten an in theh nán an insem leh ta vek bawk a ni.

India Dànpui thuhma-hruaiin India ram nihna tûr a sawi zînga pakhat chu ‘secular’ tih hi a ni. ‘Secular state’ tih emaw ‘secularism’ tih emaw awmzia kan sawi fiah duh dàn a inang lo mai thei e; tin, a hmanna hmun leh hun azirin a dang thei bawk. India ramah kan hman dàn chu hetiang hian hian khai khâwm ila: ‘*India hian eng sakhua pawh a do tihna a ni lo va; India ramah eng sakhua mah zui leh biak phal a ni lo tihna a ni lo bawk*,’ tiin.

India ramah hian sawrkarin sakhaw tih bîk a nei lo va, sakhuana thilah chuan sawrkar chu a laiin thiliar bîk a nei lo tihna a ni. Kan hriat reng tûr chu - sakhaw zalênnnaah hian sakhaw nei lote pawh an

zalêñ a, sakhaw nei lote zalênnna hi sakhaw neite zalênnna aiin a nêp bîk chuang lo.

India *Constitution*-a ‘secularism’ tih tak hi chu *Constitution* siam hlima awm a ni lo va, kum 1976-a belh chauh a ni. Mahse, an belh fuh ngang a ni ang chu, Supreme Court-in India *Constitution*-a tihdanglam theih loh (*basic feature*) a tih zîngah ‘secularism’ hi a tel a ni.

‘Part III’ kan tih hi *Fundamental Rights* inziahna a ni a. Chûng zînga *article 25 – 28* chu sakhaw zalênnna chungcháng (*right to freedom of religion*) inziahna a ni. Sakhaw zalênnna chungchâng ‘3P’ te hi ûm zui hmasa ila.

(i) Profession (puan zàrna) – Kan sakhaw chungcháng mi dang hnênah zalên leh langsâr taka sawi thei túra zalênnna.

zirtírna inah sakhaw inzirtírna kalpui a nih pawhin sakhaw dang zuitute telh luihtír khapna thlengin a huam.

(ii) Practice (nunpuina)  
– Kan sakhaw zirtírna nunpui leh serh leh sâng ti thei túra zalênnna. Chuvàng chuan, sakhaw thil bîk liau liau nia langah chuan State-in khuahkhirhna (*regulations*) a siam hi a rem lo.

Entír nán, nausen tihlum tûr záwnga zirtírna te, sakhaw hminga chêt chhuahnaa aurinna (*loud speaker*) hmanga thâwm bêngchhêng tak siam te, sakhaw dang huatna thusawi te, inthlan dáwna sakhuana behchhana *vote* hmuh tum leh hetiang lam hawi hi khap tlat a ni.

(iii) Propagation (theh darhna) – Kan sakhuua sakhaw dang betute inlehtír thei túra rinna theh darh theihna.

Hêng bâkah hian sakhaw zalênnna hian, sakhaw hmun pawimawh - zirna in te, pisa te, ɏanpui ngai ɏanpuina hmun ang chi te din leh enkawl te; sakhaw tin anmahni inrelbâwtír te; *property* neih leh enkawl te; sakhaw mal tân mipui hnênah chhiah khawn khapna te; sawrkar zirna in hrang hrangah sakhaw mal zirtírna hun siam loh te; sakhua leh mi mal din

Sakhaw pakhat atanga sakhaw danga inleh hi ‘conversion’ an ti a, hei hi kan hriat chian ngai zual pawh a ni àwm e. Chutih laiin, Hindu ni ɏthin, sakhaw danga inlet tawh, Hindu-a an kir leh hian sakhaw

danga inlet (*conversion*) a ni lo tih hre phawt ila.

Chutiang taka Dànpui-in sakhaw zalênnna a sawi lai chuan, mi ȝhenkhatin sakhaw danga inleh khapna dàn (*anti-conversion law*) an tih mai hi a awm nual thung. Chûng dànte chu sawrkar laipui dàn siam a ni lo va, *State malin an state* tána dàn an siam a ni. A siam hmasa *state* pahnih chu Madhya Pradesh leh Orissa an ni awm e. ‘*He dàn hian India Dànpui a kalk a ni*’ tiin Supreme Court-ah khin a ni a. Mahse Supreme Court chuan, “*Hêng dàn pahnih hian Constitution a kalk lêm lo e*,” tiin a puang thung (*Stainislaus v. State of MP.*)

*State* pahnih dànte Supreme Court-in a nemngheh tâk avâng hian chutiang dàn ang deuh diak diak chuan Arunachal Pradesh chuan Bill pass ve nghâl thuaiin President pawm tûrin a thawn a. He Bill hi Mizoten ‘Setana Bill’ an tih kha a ni àwm e. President-in a pawm hnuin

dàn puitling (*law*) a lo ni ta a ni. A hun laiin dodàl a hlawh viau chûngin, he dàn hian ‘*India Dànpui a kalk e*’ tiin tûn thlengin court-a zualko an la awm lo niin a lang.

Chutiang Bill ang bawk chu MP pakhat, OP Tyagy chuan Lok Sabha-ah a pu lût a, pawm a nih chuan India ram puma hman tûr a ni ang. Mahse, Pu Desai-a a ban avânga Parliament thiab a nih tâk avângin he Bill hi a tàwp zui ve ta a ni. Ngun taka sakhaw danga inleh chungchâng hi kan zir chuan, dàn thinkthu chhiatna chu, tihluihna (*coercion*) leh vehthlémna (*allurement/inducement*) hmanga sakhaw danga inlehtír hi ni berin a lang.

Sakhaw danga inleh (*conversion*) chungchâng-ah hian International Covenant on Civil and Political Rights 1966 châng 18 (2) pawhin *mimal* zalênnna tikhawlova, tihluihna hmanga sakhaw vawn luihtír emaw rinna kawnga duhthlan luihtír emaw hi a lo hnâwl tawh a ni.

State hrang hrang dàn siam chungchángah Supreme Court thutlûkna ni bera lang chu: zalén tak mahni sakhua puan darh theihna hian sakhaw danga mi dang inlehtírna a huam lo va, sakhaw danga inleh hi mi mal chanvo liau liau leh a duhthlanna tür a ni. Chuti a nih chuan han ti ilá, *direct* leh *indirect evangelism* rawngbàwlna kal tlanga miin ama chhia leh tha hriatna thiang tak hmanga Kristiana a inpe a nih chuan dàn bawhchhiatna a awm lo niin a lang.

India ram hi dàn lal berna (*rule of law*) a ni. Chuvàng chuan, kan awmna state dàn siamte hi kan zah a tûl a; kan bawhchhe tür a ni lo. Dàn bawhchia nia puhte chu court-ah thubuai siamsak (*prosecute*) an ni thin a. Dàn bawhchhiate chu thiam loh chantírin hrem an ni thin a. Mi sual lo chu thiam chantír a nih ngei theih nán theihpa tâwpa tan lâk (defence) a tûl ve

thin bawk. Sakhaw zalênnna hi *Fundamental Rights* a nih miau avàngin tu mahin min lâksak thiang lo va, min bawhchhiatsak thei hek lo.

Chuvàng chuan, *Fundamental Rights* ken-kawh nán leh a bawhchhetute hrem nán *direct-in High Court*-ah emaw *Supreme Court*-ah emaw thubuai siam nghâl theih a ni a, chu chu *writ petition* an ti. Legislature-te dàn siamin India *Constitution* kah nia kan hriat chuan *High Court* leh *Supreme Court*-ah kan khing (*challenge*) thei bawk. Chutih laiin, hmun tam takah chuan dàn ang diaka kal theih lohna, mipuiin thuneihna an inpékna (*mob rule*) hi thleng thei a ni a. Fimkhur taka kan zalênnna hman a tûl cháng a awm thin.


