Thuhmahruai

Media hian mihring nunah hmun pawimawh tak a lo luah ta a. Thil a ti theiin tunlai khawvelah chuan hmelhriat lo kan awm lo hial awm e. A hnathawh leh a thiltihtheihna hi zawk ngai loin kan ni tin nunah a lang chiang hle a ni. Media pakhat, Social media phei hi chuan rinhlelh rual loivn hmangtu a ngah chhoh zel avangin mihring inbiakpawhna hmanraw pawimawh ber a ni ta hial a ni.¹

McKinney chuan, “thu inhriattir nan, puanzar nan, infuih nan, engkim kan inhriattawnna chu social media a ni a, engkim mai hi social media kal tlangin a lo ni ta,”² tiin a sawi a, a dik hle mai. Khawvel leh mihring nunphung lo danglam zelah kohhran pawhin Biak In thleng phak lote hnen thleng thei tura rawngbawl hna hi media hmangin a kalpui ve ta a, hemi kawngah hian hmasawnna tur leh hmalak dan tur tam tak a la awm ang. Tun hma ai chuan kan kohhran (Synod) pawhin heng media-a sum, hun leh tha kan sen hi a lo tam ta hle mai. Synod-in Television leh chanchinbute hmangin rawng kan bawl mek bakah hian tualchhung kohhran hrang hrangte leh a chhunga fellowship te hian heng Facebook, Twitter, Instagram, YouTube leh WhatsApp te hi rawngbawl nan kan hmang ṭangkai ta hle mai bawk.

Hetiang khawvelah hian kohhran hian a thurin leh zirtirnaa ding nghet tlat chungin rawngbawlna zau zawk engtin nge a kalpui ang tih leh tunlai khawvela hmun pawimawh tak luanhu Media hi eng ang taka ṭangkaiin nge a hman theih tih hi kan sawi tum lian tak a ni. Invenna tur leh fimkhurna turte kan sawi tel bawk ang. A hmasa berin Media chungchang kan sawi phawt ang a, heng media-te hi kan kohhranin eng angin nge a hman tih leh zir chianna lo awm tawhte kan sawi zui ang a, chuta ṭang chuan media rawngbawlna hi eng anga kalpui nge tha ang tih kan hre thei ang.

1. Media chu eng nge?

Media tih thumal hi keimahni ṭawng ang maiin kan hmang zing tawh a, chuvangin Mizo ṭawnga lehlin kher pawh hi tunlai khawvelah chuan a ngai tawh awm lo ve. Techopedia-in a sawi dan chuan “Media hi medium tih plural form a ni a, chu chuan (a zau zawnga sawi chuan) inbiakpawhna kawng eng pawh a sawina a ni. Hei hian lehkhaa thil chhut aṭanga digital data tlengin a huam thei a, lemziak, chanchinhar, zirna thil leh thu inhriattirna chi hrang hrang hi a huam tel bawk.”³ Tichuan, Media chu hmun pakhat aṭanga hmun dang, inbiak phâk loh leh inhmuh phâk loh aṭanga midang kan biak pawh theihna hmanrua hi a ni ti ila a dik mai awm e. Chutianga kan hmuh phâk loh leh ṭawng ri pangngaia kan biak phak loha awmte kan va biak pawh theihna hmanrua: chanchinbu, *television, telephone, radio, internet, fax, telegraph* leh lehkhathawn tih ang te hi media chu an ni mai. Media chu inbiakpawhna hmanrua tiin a sawi mai theih bawk a ni. Tichuan, Media chuan mihring te kan inbiakpawhna, indawr tawnna, chanchin kan inhriat tawnna leh chutiang kawnga kan inhlunzawmna chi zawng zawng te chu a huam ti ila a fiah mai awm e. Chanchinbu aṭanga lehkhabu, lehkha thawn aṭanga mobile phone tlengin media hian a huam vek a ni.

Mithiamte chuan heng kan inbiakpawhna leh inhriat tawnna hmanraw hrang hrang, hmun hran hrana awm te pawh hmun khata awm dun ang maia kan indawr tawn theihna hmanruate chu hlawm khawmin, hlawm lianpuiah an chhung khawm ta a, chu chu *Mass Media* kan tih hi a ni ta a ni. Chu Mass media huang chhungah chuan media hrang hrang te chu chi hrang hrangin an then darh leh a, chungte chu: Print Media, Electronic Media leh Social Media/ New Age Media te an ni.

2. Media leh Rawngbawlna

Tunah chuan media chi hrang hrangte chungchang leh heng media hmanga kohhranin rawngbawlna a kalpui dan han thlir leh ila.

2.1. Print Media

Print media chuan khawla lehkha chhut hmanga inbiak tawnna leh indawr tawnna atana siamchhuah te hi a huam a. Heng lehkhabu, lekhkathawn, chanchinbu, thing phek tar (hoarding), signboard te hi a huam vek a ni. Mihring inbiak leh indawr tawnna (media) hmanraw upa ber niin John Gutenberg-a'n kum 1453-a lehkha chhutna khawl (Printing Press) a hmuh chhuah aṭang daih tawha media hmanraw pawimawh tak atana hman ṭan tawh a ni. “Mass Media” tih thu mal pawh hi helai hun aṭanga hman ṭan hi niin mithiamte chuan an ngai a ni.⁴ Vawiin tlengin mi tam takin eizawnna atan an hmang a, chanchin hriatna, inhrilh tawnna leh vawn thatna hmanraw pawimawh tak leh indawr tawnna hmanraw ṭangkai berte zinga mi a la ni ta reng a ni. Print Media hi awm ta lo se, tun anga media hmasawnna hi hmuh tur a awm kher lo mai thei a ni. Chuvangin Print Media hi Mass Media zinga hlui ber, a ṭangkaina nep thei chuang hauh lo chu a ni. Chung zinga thawh hlawk ber pakhat chu chanchinbu hi a ni.

Kan kohhran pawhin he print media rawngbawlna hi a chhawr ṭangkai hle mai a. Kum 1908-a Missionary lo kal Dr. Peter Fraser khan kuta nem kaina khawl (Hand Press) a rawn keng a, Kohhran lehkha sem chhuah tur chhut nan hman a ni a. Hemi hmanga chhut “Kraws thu” tih lehkhabu te tak te chu Mizoram chhut lehkhabu hmasa ber a ni nghe nghe.⁵

Kum 1911 October thla khan “Krista Tlangau” bu chhuah ṭan a ni a. Hei hi tuna “Kristian Tlangau” bu hi a ni. Chuvangin kum 1911 chu PRESCOM rawngbawlna bul ṭannaah pawm a ni ta a ni. Press leh Bookroom hi a din tirh aṭanga kum 44 chhung Welsh Mission kutah a awm a, kum 1955 October ni 1-ah Mizoram Synod hnena hlanna thuthlung ziah fel a ni a, kum 1956 Synod khan a pawm ta a ni. Kum 2000 aṭang khan Presbyterian Communications Department (PRESCOM) tih hming hi a pu ṭan a, hemi hma hian hming hrang hrang a pu nual tawh a ni.⁶

PRESCOM thil tum berte chu –

1. Mipui tana Kristian lehkhabu tha leh rintlak leh lehkhabu tha dangte tihchhuah leh sem darh hi Presbyterian Communications thil tum ber a ni.
2. Presbyterian Communications chuan a hnathawhah hian mahni kea din leh intodelh (self-supporting) ngei a tum a. Hemi atan hian a enkawlta Board kaltlangin lehkhabu chauh lo pawh thil dang pawh an zuarin an hralth tel bawk a ni.

Synod Bookroom hi Mizorama lehkhabu semna network lian ber a ni a, Manipur-a Churachandpur telin District khawpui zawng zawng bakah Mizorama khawpui lian deuhah te branch neiin tunah hian Branch 15 leh Distribution Centre 44 a nei mek a ni. Khaw hla deuha mipuite tan Mobile bookshop hi kum tin neih thin a ni. Bookroomah hian lehkhabu chi hrang hrang a awm a, sakhaw lam lehkhabu atanga General knowledge thlengin, naupang chhiar tur chi leh Kohhran mamawh stationeries chi hrang hrang pawh a awm. Lehkhabu hi chi hrang hrang 6000 chuang a awm a ni.⁷ Synod Press bikah hian Synod hnuia thla tin chhuak chanchinbu zawng zawng leh Sunday school zirlai bu hrang hrangte chhut thin a ni a, heng bakah hian kum tin lehkhabu 40 chuang an chhu bawk. Tualchhung kohhrante pawhin chanchinbute kan tichhuak thin bawk a. Heng chanchinbu buatsaihna atan hian Kohhran hian sum leh pai tam tak a seng a; heng chanchinbute hi kan sum sen ngaiantuahin kan chhiar tha tawk lo hle niin a lang a, hemi kawngah hian mipuite hian tan lak kan ngai hle a ni.

2.2. Electronic Media

Electronic Media hi Broadcast Media tiin an sawi bawk thin. Khawl thil (technology) hmanga hriatzauna emaw inbiakpawhna emaw, inthlunzawmna hmanrua te hi electronic media tiin kan sawi thei ang chu. Television, film, radio, movies te hi Electronic Media chu a ni.

Electronic Media chu print media ai chuan thu thehdarh kawngah a lo chak zawk hle a. Thil thleng leh chanchinte chu awlsam takin midang hmuh leh hriat theih turin an tidarh zung zung thei a. Zoram Kristiante pawh hei hian nasa takin min nghawng a. Tunah chuan in tinah Television a lo awm ta a, kan inchhungah pawh a lailum lo changing TV ah pawh smart TV a lo chhuak ta zel a. Mi tam chuan TV en nan hun tam tak kan khawhral ta thin a ni. Pathian hmaa kan inlan ai chuan TV hmaa kan hun hman hi a tam zawk ta viau mai. Hetiang taka Media pawimawh a lo nih tak avangin a tha zawng leh rawngbawl nan electronic media chu a hman theih a. Chu chu hriain Mizoram Synod pawhin helamah hian hma a la chho ve ta zel a. Synod Information & Publicity Department hi kum 2002 aṭang khan din ṭan a lo ni ta a ni. Synod Executive Committee hnuia Sub-Committee a ni a, Executive Secretary pakhatin a kaihuai mek a ni.

Tin, tualchhung TV Operator-te hnenah chanchinthar (picture) leh Sermon (Video) a pe bawk thin. He Department hian Synod hnuia conference/ meeting/function pawimawh zawng zawngte chu mipui hnena puanzar leh Archive-a dah tur video hmanga siam te pawh a huam vek a ni.⁸

Tun lai khawvelah film leh movie chi hrang hrang a lo chhuak a, sakhaw dang zuitute pawhin hmang ṭangkaiin an sakhaw zirtirnate chu movie kaltlangten an lo theh darh ta zel a. Hemi kawngah hian

Kristiante pawhin hmalak kan ngai hle. Kan tu leh faten eng thil nge an en thin tihte pawh kan hriatpui a tul hle a ni. Cartoon leh animation hmanga naupang te duhzawng tak an rawn siamchhuah hi zir chian a tul hle. Tin, kan kohhran channel-te hi ngaihhlut deuh deuh kan inzirtir a pawimawh a, hemi lama hawk Synfo hmalaknate ngaihven a, kohhran leh chhungkaw tana a tha zawnga hman chhoh deuh deuh a pawimawh.

2.3. Social Media/New Age Media

Social Media hi tunlai khawvel Media zinga thang chak ber a ni a, New Age Media tite pawhin an sawi bawk thin a ni. Tunlai khawvelah chuan internet hmangin computer leh mobile phone te hi min thlung khawmtu niin, heng hmanraw hmang hian kan inkawm a, thu te, thlalak te, video te kan inthawn kual zung zung mai a, hetianga mipui vantlang inbiakpawhna hi Social Media chu a ni. Computer, Smart phone, tablet leh internet hmanga hmaichhan ni lova ngaih dan leh chanchin inhriattirna leh inhrilhtawnna a ni kan ti thei bawk awm e. Mizorama Social Media kan hman lar deuhte chu Facebook, WhatsApp, Twitter, Instagram, Youtube te a ni. Tichuan Social Media chu ‘Internet leh Mobile phone hmanga inbiakpawhna leh inkawmhona hi a ni’ kan ti thei ang chu.

Social media-in nghawng tha lo a neih dan leh a tangkai dan te, a laka kan invenna tur leh a hman dan (media ethics) te sawi vek sen a ni lo a, helam hawi inzirtirna thuзиak chhiar tur tam tak a awm tawh. Kan sawi tum ber chu rawngbawl nan engtin nge a tangkai theih ang tih lam hi a ni ber.

Kohhranin social media a hman tangkai dan hi a inang lo hle ang a. Mizoramah chuan WhatsApp leh Facebook group siam hi kohhran ang chuan kan tih a ni deuh mai awm e. Khawpui lam kohhran hian Youtube channel an nei hlawm bawk. Hengte hi kohhran rawngbawlnaah eng ang taka tangkai nge an nih a, engtin nge kan hman tangkai zawk theih ang tih hi ngaiantuaha zir chian a hun ta hle a ni. Hetiang lama zir chianna an neih tawh tlem han tar lang ila.

BuzzPlant⁹ hi Kristianna-a innghat digital advertisement agency a ni a, kum 2012 daih tawh khan America rama kohhran 250-ah survey an nei a. Kohhran zawhna chhangtu zinga a chanve tling lo deuh chuan social media hi inbiakpawhna hmanraw ṭangkai ber nia an ngaih thu an sawi a, 25% chuan tihdan pangngai (tawngka) an duh zawk thu an sawi bawk. Hei hi kum 10 hmalamha mi daih tawh a ni a, heng hun lai hian kohhran mite zingah social media hman dan hria an la tam lutuk lo a ni. Thil lang chiang tak mai chu kohhranah hian ṭhalai lamte social media hrethiam tak leh digital language hmang thiam tak an nih rualin kum upa lam chuan harsatna an nei tih a chiang a, chuvang chuan social media kohhrana hman leh lak luh hi fimkhur a ngai hle a ni.

Kohhran Member-ten Social Media an hman dan an hmuh chu:- Member-te nena inbiakpawhna awlsam a ni a, midang fuih nan an hmang nasa tih hi a ni. Kristianna leh kohhran nun kaihhnawih thu ziak ngaihnawm leh ṭhate midangte kawhhmuh nan an hmang. Chanchin Ṭha hril nan leh ṭawngtaipui ngaite inhrilh tawn nan an hmang ṭangkai hle. Kohhran thiltih leh rawngbawlnate inhriattir nan an hmang ṭangkai bawk. Heta an zirchiannaah thil langsar deuh te han sawi ila- Media hian kohhranin Chanchin Ṭha mi chi hrang hrang hnena a thehdarh theih nan nasa takin a pui a; Media hman thiamna hian kohhran member a tipung nasa hle; Media hian Kohhran mipuite inpumkhatna leh inhriat chian lehzualna a thlen a; Member an pun phah rualin sum thawhkhawm pawh a pung.

LifeWay Research¹⁰ -in kum 2017-a a zirchiannaah chuan kohhran 70% velin an kohhrana thawktu leh an mikhualte tan Wi-Fi an pe. Kohhran 85% velin Facebook an hmang. Protestant pastor 84% chuan an kohhran Facebook chu online-a inbiakpawhna hmanraw pawimawh ber atan an hmang tih an sawi. Kohhran 15% vel chauhin Twitter leh Instagram an hmang. Kum 2017 khan Protestant pastor zinga 16% chauhvin Twitter hmangin an report a ni. Chu aia tlem zawk (13%) chu Instagram-ah an awm. American mi 65% chuan video sermon aiin in-person preacher

an duh zawk. A hmun thuma thena hmun khat (35%) vel chuan live emaw video emaw sermon hi an duh lo hle a, mahse 1% aia tlem chuan live sermon aiin video sermon an duh zawk thung.

Barna Group¹¹-in a zir chiannaah chuan kum 2017 khan Bible chhiartu zinga a chanve aia tam chuan internet (55%) emaw smartphone (53%) emaw hmangin Bible an chhiar thin an ti.

Lewis-a chuan “Kohhran hruaitu thenkhat chuan social media-in member-te nena an inlaichinna tihdanglam theihna hun remchang a siam chu an hmu chhuak mek a ni”¹² tiin a lo sawi a. Khing zirchianna ḥatanga lang chiang tak chu social media platform hmang hian rawng a bawl theih hle mai a, mi tam takin nun than neih nan an lo hmang tawh bawk. Mizorama kohhrante pawh he lam kawngah hian nasa zawkin hma kan lak a ṭul hle a ni. Hripuiin min run hnuah phei hi chuan Social Media pawimawhna hi 70% velin a pung a; kohhran pawhin hei hi kan hriat a, tun aia ḥangkai zawka kan hman thiam a ṭul dawn a ni.

3. Rawngbawlna ḥangkai leh huapzo Media!

Kohhran hnapui ber chu Chanchin Tha hril a ni a, a thil tum chu Isua hnena mi hruai luh a ni. He rawngbawl hna tihlawhtling tura kohhranin a tir ḥatanga vawiin thlenga a thawh dan chu – Pathian thu hril leh missionary tirhchhuah hi a ni ber a. Mahse tunlaia kohhranin kan harsatna tawh lian tak chu Pathian thu ngaithla tura biak ina inkhwam thin kan tlem ta hle hi a ni. Tun hi media khawvel a ni a, kohhran pawhin a hma aia nasa zawkin media kan chhawr ḥangkai thei ngei ang le!

Media hmang hian kohhran chuan mi chi tin hnen thleng turin rawng a bawl thei a. Media kal tlangin tun hmaa kohhranin a thlen theih lohte hnen a thlen theih phah ta a. Kan rama Chanchin Tha rawn thlentu, Zosap Missionary-te ngei pawh khan an hun laia Media changkang ber hmangin rawng an lo bawl a. Mizo ṭawng zir chawpin

AAW B min zirtir a, Bible an letling a. Sylhet Mission Press lamah an zuk chhuttir vang vang a nih kha! Print Media changkang ber hmangin rawng an bawl a ni. Hei vang tak hian an rawngbawlna pawh kha a chak hle reng a ni. Kan kohhran hian Print media leh Electronic media kan kalpui ve nasa ta hle a, hengte hi eng ang taka ṭangkai nge a nih zel ang? Khawvel hmun hrang hrangah sorkar leh tlawmngai pawl lian tak takten an buaipui chu ‘Raltlan’ kan tih mai *Refugee* te hi an ni. Hun kal tawh kan chhui kir chuan mi tam takte raltlan chanchin chhiar tur leh ngaihven tur tam tak a awm a ni. Raltlante dinhmun leh awm dan chungchangah ram hrang hrangten inkaihhruaina dan an siam pawh a inang lo nual bawk awm e. India Hmar Chhak State-te hi international ramria awm kan nih avangin ramdang mi lo pem luh tamna kan ni a. A bik takin heng ram Bangladesh leh Myanmar atanga lo pem lut pawh an thahnem hle a, kan khawsak dan kalphung inanna leh hmel leh pian hmang inanna avangte hian lo pem lutte pawh hi enhranna a nasa lem lo bawk a ni. Heng mahni pian leh seilenna kalsana ramdanga pemte hi *Migration* tiin a sawi theih a. Ram danga hna thawk tura kalte leh inhlawh tura mahni in leh lo kalsante pawh a huam tel bawk a. Mizoram khaw hrang hrang atang pawhin tunlaiah chuan ramdanga inhlawh tura kal chhuak tam tak thalaite an awm nghe nghe a. A dang leh chu mahni ram chhunga politics leh thil dang avanga mahni nunna him tawk lova inhriaten ramdanga mahni sahimna tura sorkar phalna laa chengte hi an ni a. Heng mite hi *Asylum* an ti a. An khawsak rei theih chhung chu phalna an neih dan a zir te a ni ve bawk a. A dang leh chu sorkar-in ram hmasawnna ni tura hma an lakna avanga khaw mite an duh lo chung hmun danga an sawn chhuah an awm leh a, chung te chu *Displaced People* tih an ni bawk a. Kan thu thlurbing atan “Raltlante” thlan a nih angin an dinhmun te, an harsatna tawh te leh an khawsak phung te bih chian kan tum dawn a ni.

1. United Nation-in Refugee a sawifiah dan:

United Nations High Commissioner for Refugees chu Indopui II-na tawp hnuah raltante harsatna su kiang turin kum 1950-ah din

a ni a. Kum 1951-ah Refugee Convention chu din niin dan leh inkaihhruaina a buatsaiah a, a tirah chuan indona avanga Europe mite hmun hrang hranga tlanchhiate dinhmun avanga din a ni. Refugee tih hrilhfiahna hmasa ber chu Leauge of Nation-in kum 1921-a Commission for Refugee-ten an lo siam tawh a. Mahse hei hi ennawnin kum 1951-ah UN chuan Refugee chungchang chu Article I-naah hrilhfiahna a siam leh ta a. A sawifiahnaah chuan, “Raltnante chu mi, tu pawh an pian leh murna rama intihduhdahna avang te, intihbuaina avang te, tharum thawhna avang te, an nunna atana hlauhawm avang tea ram danga nunna humhim mamawhte an ni,”¹ tiin. Kum 2011-ah UNHCR chuan he hrilhfiahna hi belhin, “raltnante chu mahni ram mi nihna pawnah emaw chenna hmun ngai lova khawsa emaw an nunna atana hlauhawm avanga kir thei tawh lo te, tharum thawhna laka zallenawng leh khawtlang nun inrelbawlna tibuai khawpa thil thleng avanga mahni chenna rama awm thei lo te an ni,”² tiin. Hei hi ram hrang hrangin an pawm a, rem tihna pawh an ziah hnan thlap hlawm a. Amaherawh chu India sorkar erawh chuan remtihna thuthlung hi a ziah hnan ve thei lo tlat a, UNHCR Agreement chu pawm ve lovin raltnanten inhumhim nana inkaihhruaina dan siam chu a hmang ve lo thung a ni.

India sorkar chuan sorkar rorelna (political) leh inenkawlna kal tlangin Raltnante dinhmun chungchungah kawng hmang nei takin inrelbawlna dan a nei ve thung a. Hei vang hian raltnante ho te pawh a enkawl dan a inang vek lo. A thente chu dan ang thlapin hna an thawk theiin hamhatna pek an ni a, dan ang thlapa chen phalna pawh pek an ni. A thente erawh chu heng hamhatna reng reng pek an ni ve lo thung a. Foreigner Act 1946 leh the Citizenship Act 1955-te tlawh chhanin raltnante hi sorkar-in a enkawl a ni.³ Heng dante hian raltnante chu an ramah tihduhdahna avanga lo tlanchhia an nih leh nih loh a thliar hrang lova, raltnante zawng zawngte ang khat vekin a en thung a ni. He dan hnuaiah hian lehkha pawimawh danin a phut tel lo chuan khawiah mah zin veivah phal a ni lova. An

ram lama thawn haw emaw hren theihna emaw pawh he dan chhungah hian a awm vek bawk a ni.

2. India Hmarchhak (NEI) State te leh Raltlan te:

Hmarchhak state zingah international ramri-a awmte a bik takin Arunachal Pradesh leh Mizoramah te hian raltlan an tam zual a. Hun rei tak aṭanga raltlan kan hriat theih langsar zualte lo tarlang ila:

a. Tibetan Raltlante: Sawi lan tawh angin India chu Raltlante dinhmun UN Convention-in 1951-ah leh 1967-a a siam zawmtu a ni ngai lo chungin Tibet mite kum 1950 hnu lam leh kum 1960 tir lama lo lutte chu sorkar-in raltlan nihna dinhmun a pe a. Tibetan an nih chhinchhiahna pawh pek thlap an ni a, chu chu vawi khat emaw vawi hnih emaw kum tin an ziah luh thar erawh a ngai thung a. India rama piang te pawh kum 18 an nihin chhinchhiahna (certificate) dan ang thlapin an nei thei bawk a. India sorkarin Tibet mite chu ram chhungah lo luh phal mah se, China-in kum 1951-a Tibet a run laia lo lutte dan ang thlapa dinhmun a pek ang chu pek an ni tawh lo a ni. China-in Tibet a run lai khan mihring dikna chanvo zahsak an ni lo va, an sakhow hruaitu Dalai Lama pawh tihluihnna an ram aṭanga chhuahtr a ni bawk a. China awp behna tuar zo lovin mi 80,000 vel lai chu kum 1959 khan India ramah an lo lut nia ngaih a ni.⁴ Tunah hian Tibet mi 150,000 vel lai hi India rama awm anga chhut an ni a, a tam berte chu India hmar chhak state hrang hrangah an khawsa a ni.

b. Nepali Bhutanese Raltlante: Bhutan ramah hian kum 1980 velah an rama thuneituten Nepali chengte lo pung deuh deuh chu Bhutan te chim ral theihna hlauhawmah an ngai a. Nepal mite chhiarpui chu an kalpui ta a. Tichuan, Citizenship Act of 1985 chu siam chhuakin Bhutan ram khua leh tuite dinhmun thar a duang chhuak a. Nepal mi tam takte chu zan khat thil thu-ah dan lo anga (illegal) Bhutan ram chhunga cheng an lo ni ta der a. He dan tharah hian kum 15 chhung an cheng a ni tih finfiahna an phut bawk a. Mi tam takin khua leh tui nihna chu an chan ta a ni. Hei vang hian

Nepali tam takte chu Bhutan ram aṭāṅga hnawhchhuah an ni a, heng mite hi Assam-ah leh hmarchhak state-ah an lut nasa hle a ni. India leh Nepal te, India leh Bhutan te hian Febraury 2007 khan ramri luh phalna chungchangah inremna an siam chu tih thar a ni leh a. Hetah hian India leh Bhutan sorkar-te chuan an khua leh tui te ve ve chu ang khata enin ram chhunga chen te, lehkazir te leh hnathawh te finfiahna phut kher lovin an phalsak a ni. Hei vang hian India sorkar chuan Nepali raltnante, tihluihna avanga Bhutan chhuahsante chu ṭanpuina emaw lo chhawmdawl na eng mah a pe ta lo a ni.⁵ Heng mite hi India hmarchhakah hian tam tak an inbengbel a ni.

c. Hindu Bengali Migrants: Citizenship Amendment Act siam hma zawng kha chuan India sorkar chuan heng Hindu Bengali pem lutte hi raltnante angin a pawm lova, khua leh tui anga chen phal an ni lova. An tan hna neih pawh a rem lo a ni. India ram Danpui (Constitution) leh Indian Citizenship Act 1955 chuan India leh Pakistan inthen hmaa piangte chu India khua leh tui dil phalna provision a siamsak bawk a ni.

The Citizenship (Amendment) Act, 2019 chu India rorelna sang ber chuan 11th December 2019-ah a pass a, hei hian Citizenship Act 1955 chu a thlak danglam a. Hei hian Pakistan, Bangladesh leh Afghanistan aṭāṅga India rama lo pem duh Hindu, Sikh, Jain, Parsi leh Kristian te tan kawng a in hawng ta a ni.⁶

d. Chakma leh Hajong-te: Chakma te leh Hajong mite hi Chittagong Hill Tracts-a cheng Bangladesh chhim chhak lama awm te an ni. Chakmate hi Mizoramah hun eng emaw chen aṭāṅgin an khawsa a. India Danpui (Constitution) hnuaiah Chakma Autonomous District Council pek an ni a. Chakma leh Hajong te hi East Pakistan aṭāṅgin kum 1964-65-ah an tlanchhia a, a chhan chu an chenna ram chu Kaptai Dam siam nana hman a nih avangin an hloh ta a. Muslim an nih loh avangin leh Bengali ṭawng an thiam loh avangin tihdudhahna an tuar a. Chuvang chuan India sorkar hnenah humhimna an dil a. India sorkar chuan inhumhimna buk

(relief camp) chu Arunachal Pradesh-ah a siamsak a, chutah chuan kum 50 vel zet mi tam tak an khawsa a. 2011 Chhiarpui-ah Arunachal Pradesh-ah Chakma 47,471 lai an awm a. Tripura leh Assam-ah pawh mi tam tak an cheng bawk a ni.⁷

e. Bru/ Reang: Bru hnam kan tihte hi Myanmar ram Shan State atanga lo kalin Chittagong Hill Tracts-ah leh Tripura chhim lamah an inbengbel a. A thente chu kum AD 18 bawr velah Assam leh Mizoram kal tlangin Tripura-ah an lut bawk a. Anni hi Indo-Mongoloid zinga chhiar tel an ni bawk. Tunah hian Bru-te hi Tripura-ah tribal pawl lian takte zinga pahnihnaah ngaih an ni nghe nghe. Mizoramah hian hun rei tak atangin anni hi an cheng tawha ngaih a ni. Kum 1995-ah khan YMA-in Bru-te chu Mizoram Electoral Rolls atanga an hming pah turin a phut a, a chhan chu Mizo hnathlaka ngaih an nih loh vang a ni. Heta tang hian buaina a chhuak leh zauh zauh thin. Kum 1997 khan Bru-te leh Mizote intibuaina avangin mi 37,000 lai chu Mamit, Kolosib leh Lunglei district atangin Tripura-ah an tlan lut a, inhumhimna buk (relief camp)-ah an khawsa bawk a ni. Kum 2018-ah khan Mizorama kir leh mi eng emaw zat an awm bawk.⁸

f. Myanmar Raltnante: Kum 2021 February thlaa Sipai sorkar-in Myanmar ram a awp beh hnu khan Mizoramah raltn mi 40,000 aia tam mah an lo lut a.⁹ Mizoram sorkar chuan heng raltnante hi lo tuamhlawmin khaw hrang hrangah an awmna tur camp-te siamin an mamawhte pek an ni a. Thenkhatte chu khawchhungah mi in luahin an awm bawk a. Khaw hrang hrangten raltnante lo dawngsawngin thlamuang taka an khawsakna tur an lo ngaihtuhsak bawk a ni. Camp 60 chuangah Myanmar raltnante hi an awm mek a ni.

g. Kuki-Chin Raltnante: Bangladesh sipaite leh Myanmar hel Arakan Army-te chuan Kuki-Chin-te Chittagong Hill Tracts, Bangaldesh-a chengte November 16, 2022-ah an bei chiam mai a. Heng mite hian an sahim nan Mizoramah November 20, 2022

khan an lo lut a. Raltlan lo lut hmasate hi mi 275 vel nia sawi a ni. Lawnglai district-ah leh Parva-III -ah te camp-ah an khawsa a ni. January, 2023-ah heng mite hi Mizoramah an lo tlan leh chu BSF-te chuan an lo dang a, mahse mi 62-te chu Lawnglai district-ah camp siamsak an ni a. Mi 45-te chu Parva-III khuaah an lut bawk a ni.¹⁰

h. Manipur Raltlante: Manipur buaina May 3, 2023-a thlengah khan mahni sahimna zawnga tlanchhia Mizorama rawn lut chu May 13, 2023 thleng khan mi 5,822 an tling tawh a ni.¹¹ Raltlante hi District parukah an awm a, an tamna ber Aizawl District-ah chuan mi 2021 an awm. Raltlan tam zawk chu an awmna khawtlangin an awmna hmun tur an ngaihtuahsak a, thenkhat chuan an chhungte an bel thung.

India hmarchhak leh a bik takin Mizoramah hian raltlan tam tak an lo lut a. Mi tam takte chu kir leh awm mah se, cham hlen pawh tam tak an awm bawk a. Dan ang thlapa chhinchhiah leh dan anga lo lut tam tak karah dan lo anga lo lut pawh an tam a, chuvangin Inner Line Permit (ILP) pawh state thenkhatte chuan an phut bawk a. Raltlante dinhmun hi a a derthawng a, harsatna tam tak pawh an tawk reng a ni.

3. Raltlan awm thinte avanga ngaihtuah zui tulte: Sawi lan tawh angin raltlante hi an duh vang renga ramdang emaw hmun danga mahni sahimna tura tlan an ni lova, an chenna hmuna an nunna atana a hlauhawm avanga raltlante an ni. Mahni in lum chhuahsan ngai khawp a nih chuan an boruak tawn a him lo hle tihna a ni. Chutih rual chuan an tlan luhna leh awmna khua emaw, vengte emawah harsatna an thlen ve thei bawk a. Harsatna hrang hrang an tawh theihte lo ngaihtuah ta ila:¹²

a. Khawsakna mumal lo: Raltlante hi a tam zawk chu Camp-ah an khawsa a, mahni laina hnai belte pawh awm mah se chhungkaw inenkawlna ang te tea theih tawh loh avangin an khawsak dan a mumal thei tawh lo va. An insiam rem nawk nawk mai a, hei hian

an taksa leh rilru NASA takin a nghawng a. An dam khaw chhuah theih nan a rem ang angin an khawsa ta zel mai a ni. Mahni in lum chhuahsantuten camp-a mi dang tam takte nen an khawsa a, chhungkua an inenkawlha leh invawnna te an hloh vek bawk a. An dinhmun hi a duhawm lo hle a ni.

b. Riltam an hmachhawn a ni: An tlan luhna khua leh vengte khawngaihna dawngin ei leh in turte a tirah chuan ngaiantuahsak an ni a. Pek an nih ang ang riltam hnem tur an ei mai niin a hriat a. Mamawh ang leh chak ang ei tur an nei lova. Hei hian an hriselna thui tak a nghawng thei bawk a. Ei leh in tur tha a awm si lohna chuan an taksa mai a tichhe lo va, an rilru hriselna tleng a nghawng bawk a. Hun a rei deuh chuan an mahniin ei turte pawh an inngaiantuah chawp a ngai bawk a. An tan a khirh hle awm asin. Hriselna pan deuhte chuan hei hi an tuar NASA bik hle a ni.

c. Hriselna atana invawn thianghlimna: Camp-a awmte tan invawn fai leh thianghlim hi a khirh hle awm e. Tui duh ang tawk hman tur awm lohna avang te, chenna hmun mumal loh avangte hian invawn thianghlim a harsa hle dawn a. A bik takin hmeichhiate tan a khirh zual awm e. Inthiarna leh insilfaina mumal leh tha an mamawh hle ang. Mi an tam phei chuan invawn faina kawngah hian duh viau mah se theih lohna chin a awm tlat a ni. Hei hian thui tak chu an taksa leh rilru a nghawng viau awm e.

d. Retheihna an hmachhawn mek: Raltlan tam takte hi mahni hak lai chauh la hman a, hmanhmawh tako tlan chhia an nih avangin silhfen inbel tur pawh nei lo an tam awm e. Mamawh hmasa tur tak ngial pawh keng thei lo leh la hman lo te an nih avangin an hmachhawn retheihna hi a hautak hle a ni. An awm khawmnaah thenkhat chu eng emaw chen an awm hnuah an kalsan tak in leh lova kir leh thei te an awm a, tam tak chu kir leh ngam tawh lovin bul ṭan ṭhat te a ngai a. Chhungkaw ei bel ni ṭhinte paw'n chhungkaw mamawh thawhchhuah theihna hun leh hmun an nei ta lo va. An dinhmun hi a chau hle a ni.

e. Zirna chhunzawm thei lo: Raltnan zingah hian naupangte leh thalai lehkha zir laklawh eng emaw zat an awm a. Heng mite hmalam hun hi thui tak a chhia a. Zirna an chhunzawm theih loh avangin an hmalam hun hi a eng lo hle a ni. Mizoram chhunga camp hrang hrangah sorkar hmakna leh tlawnmgai pawlte hmakna avangin naupang zawkte sikul-ah kaltir an ni a. Mahse zirna sang zawk ti mekte tan chuan a khirh hle a ni. Hei hian naupangte an inthununna thui tak a tichhia a, awm mai maina leh tih tur bik neih lohna chuan an nun a ei chhe thui viau bawk awm e. Naupang tam takte hian naupan lai hun nuam leh hlimawm hmang hlei thei lova an awm hi an lainatawm hle a ni.

f. Lehkha pawimawh (legal documents) neih a harsa: Khua leh tuiten an neih document hrang hrangte raltnante hian an neih loh avangin heng ration lak te, hna dil te an tan a theih ve loh va. Hei vang hian sorkarah chuan hna dil an tan a theih loh tawp a. Inhlawh fakna tur an mahnia an indap chawp a ngai ta thin a ni. Chutih rualin kohhran mumal lo taka awm chu an nunah tlakchham an ngah bik thin hle a ni. German Pathian thu thiam (theologian) ropui Schleiermacher-a chuan, “Kohhran kan hriat chian phawt loh chuan Pathian thu pumpui hi kan sawifiah thei lo,” tiin a sawi a. Bible chungchang te, kohhran chanchin te, thurin leh rawngbawl na chungchang te leh mihring nun awmzia te hi a khaikhawmtu pawimawh tak chu kohhran hi a ni a. Chuvangin, kohhran awmzia leh nihna te a din chhan leh kohhran mite awm dan tur te hi kan hriat chian a pawimawh hle.

Tunlai hian khawvel ram hrang hrangah kohhran pawnna rawngbawl na a tam ta em em a. Mizoram chhung ngeiah pawh ministry hrang hrang a ding tawh a ni. Mahse, Bible hi uluk taka kan zir chuan kohhran hi Pathian chatuan remruata awm a ni a, a bul chu Pathian rilru a ni tih kan hre thei. Pathian chatuan remruat chu Thuthlung Hluiah fiah vak lovin a lo lang a, Thuthlung Tharah fiah zawkin tarlan a ni a. Lal Isua thihna leh thawhlehna atangan hmuh theih kohhran chu khawvelah a lo ding chhuak ta a. Isua ngeiin ‘Ka kohhran’ a tih avangin kohhran hi Lal Isua atanga lo piang chhuak ngei a ni tih hi hnial rual loh-a chiang a ni. Amah ngeiin, “He lungpui

Kohhran chungchang Bible-in a sawi dan

Thuthlung Hluiah hian kohhran tih တော်ကံကမ် tak hi a awm lo va. Mahse, Hebrai တော် Edah leh Qahal tihte hi kohhran sawi nan hman a ni. *Qahal* tih chu ‘koh’ tihna a ni a, tih tur neia mipui koh khawm emaw kalkhawm emaw sawina a ni. *Edah* tih chu ‘ruat’ tihna a ni a, hmun ruat bika kalkhawm emaw ruat an nih avanga inhmukhawm emaw sawi nan hman တိုင် a ni. Grik တော် an lehlinnaah chuan edah hi sunagogue (lo pung khawm) tia lehlin a

ni a, *qahal chu ekklesia* (ko chhuak) tia lehlin a ni bawk. Heng ḥawngkamte aṭang hian ‘kohhran’ tih ḥawngkam hi a lo piang chhuak ta a ni.

Tichuan, Kohhran tih chu Pathianin tih tur leh hlen chhuah tur neia a koh chhuahte a kawk a. Mipui pungkhawm satliah ni lovin, a kotu koh chhan tihlawhtling tura pung khawm tihna a ni. Pathianin Abrahama a koh khan a hnenah, “**Nangmahah chuan leia hnam tin an la thawveng ang,**” (Gen 12:3) a ti a. Tichuan, leia hnam tin thawvenna tur Krista a lo lan hmain Abrahama thlah hnam pum pui chu Pathianin tih tur bik neiin khawvel hnam tam tak zing aṭangin a kovin a thlang a (*Deut 7:6, Ex 19:6*). Hei hi ‘**Thuthlung Thar Kohhran hlimthla hmasa**’ chu a ni. Mahse Pathian hnam thlan Israel-te chuan Pathianin a koh chhan an tihlawhtling thei lo va. Chuvangin, Pathian chuan a Fapa thihsna leh thawhlehnsa hmangin Thuthlung Thar Kohhran chu a rawn din ta a ni.

Thuthlung Tharah hian vawi tam tak kohhran tih ḥawngkam hi kan hmu a, kohhran lam hawi zawnga thusawi pawh a awm nual mai. Chanchin Tha buah-te erawh vawi hniih chiah (Mat 16:18; 18:17) kan hmu thung a ni. He ḥawngkam hian veng khata ringtute inhlawm khawm a kawk thei a (Tirh 5:11; 1 Kor 11:18). Biak in pakhata inkhawmho a kawk thei a (Rom 16:23; Kol 4:5), khawvel puma ringtu Pathian be tura inhlawm khawm a kawk thei a (1 Kor 10:32; 12:28), lei leh vana mi zawng zawng Krista chhandamtua pawmtute a kawk thei bawk (Eph 1:22; Kol 1:18,24).

Kohhran sawifiahna ḥawngkam hrang hrangte hian kohhran nihna min kawhhmu a. Kohhran lu chu Krista a ni (Gal 1:18) tih hian Kohhran inngahahna leh a bulpui ber chu Krista a nihzia min hrilh a; Krista taksa (Eph 1:20; Kol 2:19) tih hian Kohhran leh Isua Krista in zawmna chiang takin a tilang a; Pathian in (1 Kor 3:16; Eph 2:21f) tih hian kohhran chu Pathian chenna hmun a ni tih min kawhhmu a; Jerusalem thar/chung lam Jerusalem (Gal 4:26; Heb 12:22; Thup 21:2) tih hian kohhran chu Pathian khawpui, van nena

inzawm a nih thu min hrilh a; thutak ban leh innghahna (1 Tim 3:15) tih hian Kohhran rin tlakzia min kawhhmu bawk a ni. Chutiang taka ropui kohhrana kan tel ve ngawt mai hi kan vannei hle a ni.

Kohhran aw ngaih pawimawh

Kohhran chu Pathian chenna a ni a. Chutah chuan a mite a hruai lut a, a duhzawng leh a thupek a hriattir ḫinna hmun a nih avangin ‘kohhran aw chu Pathian aw a ni’ tiin an sawi ḫin. ‘Kohhran aw’ tih hian kohhranin kalphung nghet a neihte leh inkawmpui leh committee rorelte a kawk ber. Bible-ah hian kan tih tur leh tih loh turte ziak a ni a. Mahse, kan hun tawng ang zela tih awm leh tih awm lohte indawt fel taka ziak thlap a ni lo va, nun dan kaihhruaina pui (principles) a ni ber zawk a ni. Kohhran chuan chu chu ni tina kan mamawh angin a lo rel fel ḫin. Chuvangin, kohhran chu kan hun tawng ang zela hman tur Pathian thu min hrilhtu a ni a. Pathian hruaina kan hmuh fiah theihna tur te, Pathian leh a Kohhran aṭanga kan vah bo lohna tur te, a duh zawnga kan nun zel theihna tur tea min kaihruaitu a ni. Chutiang chuan Pathian hian a kohhran hmanga min hruai ḫin avangin ‘kohhran aw chu Pathian aw a ni’ tiin kan inzirtir ḫin a ni.

Kohhran leh a neitu Pathian hi an inzawm tlat a, lak hran theih a ni lo. Paula pawh khan a pianthar hma chuan kohhranho a tiduhdah ḫin a. Amah ngei pawhin a chanchin a sawinaah, “Thahnemngaih lamah chuan kohhranho tiduhdahtu ka ni a,” (Phil 3:6) tiin a sawi a ni. Damaska daia engin a chhun tluk khan a hnenah Isua a inlar a, “Saula, Saula, nangin engati nge mi tihduhdah? Chhunna tiang khen i tan a na e,” (Tirh 26:14) tiin a sawi mai a ni. Hei hian kohhran leh Pathian chu an inzawm a ni tih a tilang fiah hle. Heng thu aṭangte hian kohhran chuan sawiselna leh beihna hi hman aṭang tawhin a tuar reng ḫin a ni tih kan hre thei a; mahse, thurin khawih a nih lem loh chuan kohhran hian mahni insawifiah a tum ngai lem lo. Thu dik leh tha nia a hriat chu huaisen taka zirtirin a kal pui zel mai ḫin zawk a ni. Chuvangin, kohhran inkhawmpui leh committee-in kan

that tlanna tur bera a rel lo zazm zel mai hi kohhran mite tan chuan
a thain a him ber a ni.

Kohhranah hian kan tel ve a nih chuan member ‘satliah’ a nih theih loh va, kohhran mi zawng zawnge hian mawhphurhna kan nei vek a ni. Kan dinhmun a zirin thil tam tak ti thei lo mah ila kohhran miten kan tih theih pawimawh ber pakhat chu kohhran laka rinawm tlat hi a ni. Kawng danga sawi chuan Pathian laka kan rinawmna chu kohhranah a lang chhuak tur tihna a ni ber mai. Kohhran rorel ngaih pawimawh leh zawm te, kohhran thurin leh inkaihhruaina zah thiam te, Pathian ram thawhlawm leh thilpek dang pek te, a thilserh ngaihsan te, kohhran programme ngaih pawimawh te, mawhphurhna hlen tur a theihtawp chhuah te hi thil pawimawh tak a ni.

Kohhran rawngbawl hna

‘Rawngbawl/Rawngbawl Hna’ tih hi ɣawngkam haus a ni a, hrilhfiah tawk thiam pawh a har hle. A ɣawng bul lam aṭang a awmzia ber chu ‘midang tana thiltih’ (service) a ni a. Intihlalna leh chapona tel lova tlawm taka mi dangte tana thawhsakna hi a awmze bul ber chu a ni. Thuthlung Thar-a rawngbawlna sawina ɣawngkam hrang hrangte pawh hian, rawngbawl hna chu inngaitlawm tak a thawh tur a nihzia leh, a tirtu thu ang zela thawh tur a nihna lam a dah langsar hle a ni. Heta ɣanga thil lo lang chiang tak chu rawngbawl hna chu inngaitlawm tak leh thunuairawlh tak chunga mi dangte thatna tura hnathawh hi a ni. Rawngbawltu nuam tih zawng leh chak zawng aiin rawngbawl sakate mamawhnain rawngbawl hna chu a kaihuuai thui hle kan ti thei awm e.

Lal Isuan rawngbawl hna a rawn thawh pawhin chhiahhlawh
anga rawngbawlna a langsar a. Rawngbawltu chu rawngbawlsaka
awm tur a ni lo va, mi te ber leh chhiahhlawh angin mi dang rawng
a bawl sak zawk tur a ni (Mk. 10:42-45). Ama nun leh rawngbawlna
ngeiin chu chu a lantir a, inngaitlawm leh thuawih takin, bawih angin
a thawk a. Berampu tha nihna a sawi chu ama nun ngei pein a hlen
chhuak a ni.

Kohhran huang chhungah rawngbawl hna peng hrang hrang thawk turin Pathianin mite a ko va, an rawngbawlna tur leh an dinhmun turte pawh a ruat sak a ni tih min zirtir a. Chung rawngbawl hna peng hrang hrang atan chuan thlarau thilpek chi hrang hrangte pawh a awm thu min kawhhmu (1 Kor.12:4-6). ‘Krista Taksa’ siam puitlin zelna leh chawmna atan chuan mawhphurhna leh chanvo hrang hrang a awm thu pawh kan hmu bawk a ni (1 Kor.12:28; Eph.4:13). Mizoram Presbyterian Kohhranin rawngbawlna kan kalpui dan atangin heng Thuthlung Thar Kohhrana rawngbawl tu pawimawh tak takte dinhmun leh hna te hi han thlir thuak thuak ila.

Pastor leh Probationary Pator te: Kohhran rawngbawl hnaah hian Pastor te hi dinhmun pawimawh ber luahntute an ni ti ila a sual awm lo ve. Kohhran hotu, Krista Chanchin Tha hril tur leh sakramente buatsaih tura a bik taka dan ang taka nemngheha serh hrante an ni a, an dinhmun leh mawhphurhna hi a pawimawh em em a ni. Kan Kohhran Dan Bu chuan, “Minister-te chu kohhran hotu, Krista Chanchin Tha hril tur leh sakramente buatsaih tura dan ang taka nemngheha serh hrante an ni,” a ti. (II 6: iv) Heta tang hian Pastorte chu kohhran hotu (Bishop), thuhrltu (Evangelist), sakramen khawih tura nemngheh (ordain), leh rawngbawl tu (servant) an ni tih a hriat theih. Pastor nemnghehna hi thil ropui leh pawimawh tak a ni a, kamdinna leh eizawnna (career) anga ngaih mai tur a ni lo. Pastor-te nihna leh mawhphurhna hi hetia sawi mai a awlsam ang ai hian a takah chuan thawh zawh tih awm thei lo, nihna leh mawhphurhna hautak tak a ni. Pastor-te bakah hian Pastor atana buatsaih mek Probationary Pastor-te an awm bawk a. Kan Dan Bu chuan “Probationary Pastor-te chu rawngbawl hna puitlinga nemngheh an nih hmaa Minister kaihruaina hnuaiia Pastor lam hna thawk tura enhhin atana lakte an ni,” tiin a sawi a. (II 6: iii). Pastor atana buatsaih leh enthlak mek an ni, an nungchang leh hnathawh dan te a lungawi thlak chuan nemngheh theih an ni a, nemnghehna chungchanga thu tawp neitu chu Synod chauh a ni.

Kohhran Upa: Thuthlung Thar Kohhran a lo din khan Upate chu kohhran sum ngaihtuahtu atan thlan an ni a (Tirh.6:2-6); mahse a tak taka rawngbawlna ah chuan Tirhkohte kha an thawhpui ta zel a ni. Kan ram kohhranah hian Upate chu kohhran neitu tak tak an ni a, an dinhmun leh mawhphurhna hi a pawimawh em em a ni. Kan Kohhran Dan Bu chuan, “Upate chu kohhranin an aiawh hotu atan an thlan, kohhran thlarau lam nunah te, rorelna lamah te, rethei enkawlah te leh kohhran sum relbawl kawngah te, Pastor tanpui tura nemnghehna hmanga serh hrante an ni,” tiin a sawi a (II 6: i). Heta tang hain kohhran Upate chu hotu, chawmtu, roreltu, enkawltu, sum relbawltu, leh Pastor-te thawhpuitu an ni tih hi a fiah hle.

Pastor hna kan sawi ang khan Upate hna pawh hi thawh zawh tak tak awm thei lo, rilru leh ngaihtuahtu zawng zawng nena thawh ngai a ni a, a hautak hle. Kohhran chhiat-thata mawhphurtu ber an nih avangin kohhran mite pawhin kan ḥawngtaipui fo a ṭul hle a ni.

Thuhrltute: Kohhran kalphunga rawngbawlta pawimawh leh langsar tak te chu thuhrltute hi an ni. Khawvel hmun dangah chuan kohhrana thuhril hna hi zir mite leh nemngheh mite tih tura ruat a ni thin a. Mizoramah erawh hi chuan Kohhran Committee-in tualchhunga thuhril thei awm mi thenkhat, kum khat chhung atan a ruat mai thin. A pawimawhzia leh duhtui a ṭulzia hi hriat a tha hle a ni. Rev. Saiaithanga phei chuan, “Hril thei lo nia hriat chu ruat nawn fo tur a ni lo va, an thu hrisel tawk lo va hriat phei chu, thiam lo aiin a tha lo zawk a ni,” a ti.

Rawngbawlta Dang-te: Achunga kan sawi bakah hian kohhran rawngbawl hna peng hrang hrangah rawngbawlta pawimawh tak tak an la awm a. Sunday school zirtirtu te, committee hrang hranga member te, Kohhran Hmeichhia, Thalai leh Pavalai lam hruai te leh Kohhran Office hrang hranga thawktute zawng zawng pawh hi rawngbawlta pawimawh leh ḥangkai tak vek an ni. An nihna leh dinhmun a thuin mawhphurhna leh rawngbawl dan pawh a dang thei viau a, amaherawhchu a bulpui berah chuan Pathian

rawngbawltu vek an ni. Tin, kan kohhran hi ringtu zawng zawngte puithiamna pawmtu kan ni a. Chuvangin, kohhran mi zawng zawngte hi kan phak tawk leh theih ang tawk zela rawngbawl hna thawktute kan ni vek a tih theih awm e.

Tlangkawmna

Khawvel lo dang zelah hian kan rilru put hmang pawh a lo inher danglam ve zel a. Kohhran leh rawngbawl hna kan hriatthiam dan leh kalpui kan duhdan pawh a pangngai reng thei hek lo.
